

DEPARTMENT OF WATER AND ENVIRONMENTAL REGULATION Clearing permit required for Cocos (Keeling) Islands native vegetation including the coconut tree, *Cocos nucifera*

The Commonwealth Government, through the Service Delivery Arrangement with the Department of Water and Environmental Regulation (WA) have completed a recent assessment of native vegetation species that exist on Cocos (Keeling) Islands.

This assessment has identified and confirmed the coconut tree, *Cocos nucifera* found on Cocos (Keeling) Islands and historically formed plantations on the islands is considered native vegetation where it is growing along the shoreline (indigenous environment) where seed nuts can naturally move and germinate. Where it is growing outside its indigenous environment i.e. inland areas and within the historical plantations of the islands, it is not considered native vegetation under the *Environmental Protection Act 1986(WA)(CKI)*.

As a result, the clearing of *Cocos nucifera* in its indigenous environment (shoreline areas) is subject to the clearing provisions for native vegetation under the *Environmental Protection Act 1986(WA)(CKI)*.

Please be aware that all clearing of native vegetation on Cocos (Keeling) Islands, including the coconut tree *Cocos nucifera* within its indigenous environment, can only be done:

- in accordance with a clearing permit obtained from the Department of Water and Environmental Regulation (WA);
- where an exemption is available pursuant to Schedule 6 of the Environmental Protection Act 1986(WA)(CKI),
- 3) where an exemption is available under Regulation 5 of the *Environmental Protection (Clearing of Native Vegetation) Regulations 2004* and the area is not declared to be an environmentally sensitive area, or
- 4) in accordance with a notice issued under section 51DA(5) of the *Environmental Protection Act 1986(WA)(CKI)*,

The clearing of native vegetation otherwise then in accordance with the *Environmental Protection Act 1986(WA)(CKI)* is an offence.

Kerajaan Komanwel bersama dengan Service Delivery Arrangement dan Department of Water and Environmental Regulation (WA) telah melalukan pernilaian kepada pokok asli yang ada di Cocos (Keeling) Islands.

Penilaian ini telah mengenal pasti dan mengesahkan bahwa pokok kelapa, *Cocos Nucifera* yang terdapat di Cocos adalah pokok yang timbul dari sejarah di pulu dianggap sebagai pokok asli dimana ia timbul di sepanjang pinggir laut (persekitaran asli) dimana buah kelapa boleh bergerak dan timbul semula. Jika pokok kelapa timbul di luar persekitaran aslinya iaitu kawasan dalam dan tempat yang orang tanam kelapa dulu, ia tidak di nyatakan sebagai pokok asli di bawah undang- undang *Environmental Protection Act 1986(WA)(CKI)*.

Sebab ini, melapangkan *Cocos nucifera* di tanah aslinya (kawasan pinggir laut) tunduk pada ketentuan melapangkan pokok asli di bawah undang-undang *Environmental Protection Act* 1986(WA)(CKI).

"LAWA's IOT Service is fully funded by the Australian Government" How the Civil Law Division of Legal Aid WA help you II

These are short articles about legal issues that may interest you. They are not legal advice. You should always get individual legal advice for your situation.

In this article we will continue to look at what the Civil Law Division of LAWA can do for you.

Mortgage Hardship Service in the Civil Law Division

You might be having difficulty meeting your mortgage payments or have fallen behind in your payments. This is called mortgage hardship. There is a team of lawyers in the Civil Law Division who can help, called the Mortgage Hardship Service.

The team of lawyers in the Mortgage Hardship Service can help you by giving legal advice about what to do if you:

- are financially stressed by your mortgage repayments
- are behind with your mortgage payments
- have been given a default notice (a notice telling you that you are overdue with your mortgage repayment and requesting payment)
- have been given a Supreme Court writ to take your property from you
- have been told the sheriff is repossessing your home
- gave a guarantee for someone else's loan and your own home is now at risk of repossession.

If you are behind on your mortgage repayments, it is important to seek help quickly. This is because the options available to you can get less the longer the situation continues.

Work and Development Permit team

If you have court fines and do not pay them, the Fines Enforcement Registry (FER) can take enforcement actions against you to satisfy your fines debt. One example is the FER can sell your personal property or real estate to satisfy the debt.

There is a team in the Civil Division called the Work and Development Permit (WDP) team. The team can help you manage a debt you have from court fines if you are having trouble paying them. Email wdpservice@legalaid.wa.gov.au

The team can help you:

- Negotiate a payment plan with the FER.
- Apply for a Fine Expiation Order (this is where if you have spent time in custody, your fine is reduced by each day in custody).
- Refer you for a Work and Development Permit (WDP).

A WDP lets you get together with certain organisations (called "sponsor" organisations) and do "approved activities" to clear your fine debt. Approved activities include volunteer work, counselling, medical treatment or education. If you have a WDP you can get support in the community, reduce your debt and avoid enforcement action.

The team also has a coordinator who helps the sponsor organisations or organisations applying to become sponsors.

Defence and Veterans Legal Service team

There is currently a Royal Commission into Defence and Veteran Suicide. If your mental health, or the mental health of a loved one, has been affected by your time in the ADF service, or you were not supported properly after you left the ADF the Royal Commission wants to hear your story.

There is a team in the Civil Division called the Defence and Veterans Legal Service (DAVLS). The team can give you legal advice and support if you are or were in the Australian Defence Force and you want to be heard by the Royal Commission. The team can also help your family members, carers and supporters.

DAVLS can help you prepare a submission and advise you about how to share your story safely. The team can also connect you with other legal and non -legal support for matters that are not related to the Royal Commission.

Social Inclusion Program team in Civil Law Division

You might have a complicated civil legal problem such as a debt, a court judgment against you (a court order saying you owe money to someone), a guardianship or administration problem, a social security law problem or a COVID-19 problem.

There is a team called the Social Inclusion Program (SIP) in the Civil Division. It can help you solve complicated civil law problems affecting your daily life. The team has an emphasis on helping solve your legal problems and disputes by negotiating and advocating on your behalf.

Federal Court Self-Represented Litigants Service in Civil Law Division

You might have a legal case in the Federal Court where you are representing yourself.

There is a team called the Federal Courts Self-Represented Litigants Service in the Civil Law Division. It can give you advice if you are representing yourself in the Federal Circuit or the Family Court of Australia (General Division) or the Federal Court of Australia. The team can advise you about court procedures and help you draft your documents for your case.

The team helps with different kinds of matters, such as migration, fair work and employment, bankruptcy, anti-discrimination, information privacy, competition and consumer, and appeals from Federal Courts and Tribunals. Bagaimana Bahagian Undang-undang Sivil Bantuan Hukum WA membantu anda II

Ini adalah artikel pendek mengenai perkara undang-undang yang mungkin menarik untuk anda. Ini bukan nasihat undang-undang. Anda mesti selalu mendapatkan nasihat undang-undang sendiri untuk keadaan anda.

Dalam artikel ini kami akan terus melihat apa yang boleh dilakukan oleh Bahagian Undang-undang Sivil LAWA untuk anda.

Serbis Mortgage Hardship di Bahagian Undang-undang Sivil

Anda mungkin menghadapi kesusahan untuk menemuhi pembayaran mortgage anda atau ketinggalan dalam pembayaran anda. Ini dipanggil mortgage hardship. Ada team pengacara di Bahagian Undang-undang Sivil yang boleh membantu, yang dipanggil Mortgage Hardship Service.

Team pengacara di Mortgage Hardship Service boleh membantu anda dengan memberikan nasihat hukum tentang apa yang harus dilakukan jika anda:

- tertekan dari segi keuangan oleh bayaran mortgage anda
- ketinggalan dengan pembayaran mortgage anda
- telah dikasi notis (notis yang memberitahu anda bahawa pembayaran mortgage anda overdue dan meminta pembayaran)
- telah dikasi surat perintah Supreme Court untuk mengambil properti anda dari anda
- telah dikasi tahu yang sheriff mengambil semula rumah anda
- memberikan jaminan atas pinjaman orang lain dan rumah anda sendiri sekarang berisiko untuk diambil kembali.

Jika anda ketinggalan membayar mortgage anda, adalah penting untuk mendapatkan bantuan secepat mungkin. Ini karena pilihan yang tersedia untuk anda akan berkurang apabila keadaan berterusan.

Team Permit Kerja dan Pengembangan

Jika anda mempunyai denda mahkamah dan tidak membayarnya, Fines Enforcement Registry (FER) boleh mengambil tindakan penguatkuasaan terhadap anda untuk membayar hutang denda anda. Salah satu contoh ialah FER boleh menjual properti peribadi anda atau real estate anda untuk membayar hutang.

Terdapat satu team di Bahagian Sivil yang dipanggil Work and Development Permit (WDP) team. Team ini boleh membantu anda menguruskan hutang yang anda ada dari denda mahkamah jika anda menghadapi masalah membayarnya. Emel wdpservice@legalaid.wa.gov.au

Team ini boleh bantu anda:

- Merundingkan pelan pembayaran dengan FER.
- Mohon Perintah Pelunasan Denda (di sinilah jika anda telah menghabiskan masa dalam tahanan, denda anda dikurangkan setiap hari dalam tahanan).
- Merujuk anda untuk mendapatkan Work and Development Permit (WDP).

WDP membolehkan anda berkumpul dengan organisasi tertentu (dipanggil "sponsor" organisations) dan lakukan "activiti yang disetujui" untuk melunasi hutang denda anda. Activiti yang disetujui termasuk pekerjaan volunteer, kaunseling, rawatan perubatan atau pendidikan. Jika anda mempunyai WDP anda boleh mendapatkan sokongan dalam masyarakat, mengurangkan hutang anda dan elakkan tindakan penguatkuasaan.

Team ini juga mempunyai koordinator yang membantu organisasi sponsor atau organisasi yang memohon untuk menjadi sponsor.

Serbis team Undang-undang Defence dan Veterans

Saat ini ada Royal Commission Pembunuhan Diri untuk Defence dan Veteran. Jika kesihatan mental anda, atau kesihatan mental orang yang anda sayang, telah terpengaruhi oleh masa anda di ADF, atau anda tidak disokong dengan betol setelah meninggalkan ADF, Royal Commission ingin mendengar cerita anda

Ada team di Bahagian Sivil yang dipanggil Defence and Veterans Legal Service (DAVLS). Team ini boleh kasi anda nasihat dan sokongan undang-undang jika anda berada atau pernah berada dalam <u>Australian Defence Force</u> dan anda ingin didengar oleh Royal Commission. Team ini juga boleh bantu <u>keluarga</u>, penjaga dan penyokong anda.

DAVLS boleh membantu anda menyediakan penyerahan dan menasihati anda tentang cara berkongsi cerita anda dengan selamat. Team ini juga boleh menghubungkan anda dengan sokongan undang-undang dan bukan undang-undang lain untuk perkara yang tidak berkaitan dengan Royal Commission.

Team Program Social Inclusion di Bahagian Undang-undang Sivil

Anda mungkin menghadapi masalah undang-undang sivil yang sulit seperti hutang, putusan mahkamah terhadap anda (perintah mahkamah yang mengatakan anda berhutang uang kepada seseorang), masalah penjagaan atau administrasi, masalah undang-undang keselamatan social atau masalah COVID-19.

Terdapat satu team yang dipanggil Social Inclusion Program (SIP) di Bahagian Sivil. la boleh membantu anda menyelesaikan masalah undang-undang sivil yang mempengaruhi kehidupan sehari-hari anda. Team ini memberi penekanan untuk membantu menyelesaikan masalah undang-undang dan perselisihan hukum anda dengan berunding dan menyokong bagi pihak anda.

Serbis yang Diwakili Sendiri oleh Federal Court di Bahagian Undang-undang Sivil

Anda mungkin mempunyai kes undang-undang di Federal Court dimana anda mewakili diri sendiri.

Ada satu team dipanggil Federal Courts Self-Represented Litigants Service di Bahagian Undang-undang Sivil. la boleh kasi anda nasihat jika anda mewakili diri anda di Federal Circuit atau Mahkamah Keluarga Australia (General Division) atau Federal Court of Australia. Team ini boleh kasitahu anda tentang cara mahkamah dan membantu anda Menyusun dokumen untuk kes anda.

Team ini membantu dengan berbagai jenis perkara, seperti migration, kerja dan pekerjaan yang adil, kebankrapan, anti-diskriminasi, informasi privasi, persaingan dan pengguna, dan rayuan daripada Federal Courts dan Pengadilan. 




