

From the CEO's Desk 11 August 2023



Housing Policy and Community Housing: Thank you to all those who attended the housing policy community consultations with Civic Legal recently, what an amazing turn out for such a vital conversation. Anthony and Mel (Civic Legal) were able to take away a lot of valuable information and from this you will soon be complete community asked to survey regarding а housing/leasing/rental. Once we have sent all the survey results back to Civic Legal, they will analyze the results and provide Council with a draft Housing Policy. This policy will take the place of the currently outdated Kampong rental/leasing housing policy and procedures and will provide a clear pathway forward, that has been built around your thoughts and ideas. Once this process is complete, Civic Legal will then commence the process of

investigating the way forward with land tenure to the Cocos Malay people and the first step is to determine if that is legally possible.

Waste Management and Associated Policies: To everyone who has contributed their thoughts to the development of the waste management/small business policy for the Cocos (Keeling) Islands, I thank you very much. The response from community was very, very, positive and has provided a great cross section of thought. I will now be reviewing all contributions and doing some research prior to putting a draft Policy to Council that I hope will be acceptable to community and Council.

In terms of waste management, the historical/legacy waste is an enormous problem for the islands and that includes the asbestos that has been dumped in the bush, left lying around or buried. The Shire President has this week written to the Hon Tanya Plibersek Minister for the environment seeking support from the Commonwealth to transfer all this waste off the islands.

My apologies for the error in not putting the full page that showed all 2023 – 2024 waste management fees and charges in the Atoll (two editions ago), the full list is replicated here for your information.

With the Ferry being out of commission for a couple of weeks, you may see a reduction of services, but we will endeavor to keep your bins empty and the transfer station open when possible.

Future Planning: The Shire plays a big role in the future of the Cocos (Keeling) Islands, but we are only as good as the planning that backs up our processes. Having been here for over 12 months now I am getting to know which way the wind blows and the sun sets. It is my

desire to set the direction and future in terms of long and short term planning with the full support of the new Council (post October elections) and the whole community. I will be holding a whole of community (West and Home Islands) planning day on Home Island in November to set the tempo for the future. Between now and then I will be posting updates and references to Shire documents for you to be aware of and keep in mind.

Boat Ramp: Congratulations to the Pete McCartney and the boat ramp group who are working to make sure there is a functional boat ramp on West Island. It is great to see such an initiative and a bit of civic input goes a long way and from the Shire perspective, we will be working hand in hand with the group. We all recognize the need for an allweather, all year round boat ramp suitable for the launch of recreational and emergency watercraft. We are still investigating the possibility of the Commonwealth funding a



boat ramp and the Shire President has this week written to the Minister for Emergency Management the Hon Murray Watt and the Minister for Transport the Hon Catherine King seeking support. We need all agencies including AFP, Parks, Tourism, CRC, CMC, residents and ratepayers and tourists to work together and support the Shire in our bid for funding.

It is very difficult to understand that the Minister for Territories, The Hon Kristy McBain, who is the local member for the seat of Eden Monaro, fails to support a boat ramp on West Island. The seat of Eden Monaro has great connection to the ocean especially, recreational and commercial fisheries that use the ramps along the east coast of Australia in her electorate. I can only image the furor if the boat ramp at Eden was covered by 3 meters of sand and unusable!!!!! c'mon Minister.

The Shire President has also written to the Minister seeking support that has been steadfastly refused in the past. To support Pete and his band of helpers and to bring a voice loud and clear from Cocos, Pete and I will be designing a community petition sometime next week to further add support to our argument for boat ramp funding. If you have any ideas or thoughts around this, please see Pete or myself.

Runway Upgrade Project: As the CEO, representing the Shire, this week I attended a meeting with AECOM, Fulton Hogan and Department of Defence Property Management to clarify some minor issues and get an update on progress of this project. The contract has yet to be let and is still under negotiation in Canberra. However, planning for the project is still happening behind the scenes and there is hope of a visible presence of the contractors by the end of the year with the Material Off Load facility coming on line early in the new year.

A traffic management plan for West Island has not yet been developed and Fulton Hogan will provide information to the Shire to inform the community regarding traffic arrangements for the project - upon confirming the solutions with Main Roads and Defence.

CHARMAP is obviously a huge body of work and at this point in time to assist the Shire with leases over 2 minor portions of land, at this point in time, Defence Properties will draft a letter to the Shire regarding their approach to CHRMAP considerations.

As contract negotiations progress, things will move very quickly with the project so regular meetings with the project management team will occur so information can be passed on to the community.

Local Government Elections: Local Government elections are approaching very quickly and will be held on 21 October 2023, candidate nominations will close on 7 September 2023. Our Shire will have an extraordinary election for 1 candidate for 2 years and an ordinary election for 3 candidates for 4 years. This is a great opportunity for anyone interested in having a say about the future of the Cocos (Keeling) Islands and the strategic direction of the Shire. Anyone who would like to have a chat about what is involved please contact me or attend an online session or attend one of the community sessions being planned. Our website also contains details of the elections and information for prospective candidates.

Road Closures: It is the time of the year when high tides and larger than normal swell combine for tidal inundation that closes our roads especially heading south on West Island. The big tides and swell recently caused extensive damage to the roads and south road will have to be closed for repairs in the not too distant future. The decision to do this is not taken lightly and as we have agreed in the past, if anyone requires to get to the south end of the island when the roads are closed, they need to send me an email <u>frank.mills@cocos.wa.gov.au</u> requesting permission and the reasons why.




We will still put road closures on south road, the board at the club and on social media for information. To the kite surfers and tourists, I apologize for any inconvenience but each year the damage to our road network is getting worse and the closures are a necessity to get them back to a safe and reasonable standard.

The Shire President has this week written to the Hon Chris Bowen Minister for climate change and the Hon Senator Assistant Minister McAllister seeking support from the Commonwealth to carry out urgent repair and mitigation works on West Island to mitigate further damage.

CEO update

Undang-undang Perumahan dan Perumahan Masyarakat: Terima kasi kepada semua yang hadir di perundingan undangundang perumahan masyarakat dengan Civic Legal, hasil yang luar biasa untuk perbualan yang begitu penting. Anthony dan Mel (Civic Legal) banyak mengambil informasi berharga dan dari ini anda akan diminta untuk membuat survei masyarakat mengenai perumahan/leasing/sewaan. Setelah kami hantar semua hasil survei kepada Civic Legal mereka akan melihatnya dan menyediakan draf Undang-undang Perumahan kepada Konsel. Undang-undang ini akan menggantikan undang-undang dan prosedur perumahan sewa/leasing yang lama dan akan memberikan jalan yang jelas ke depan, yang telah dibuat mengikut pemikiran dan idea anda. Setelah proses ini selesai, Civic Legal

akan memulakan penyiasatan proses jalan ke depan dengan kepemilikan tanah kepada orang-orang Melayu Cocos dan langkah pertama adalah untuk menetukan apakah itu mungkin secara hukum.

Pengurusan Sampah dan Undang-undang Berkaitan: Kepada semua yang telah kasi pendapat mereka untuk membuat undang-undang pengurusan sampah/bisnis kecil untuk Pulu Cocos, saya mengucapkan ribuan terima kasih. Jawapan dari masyarakat sangat positif dan memberikan wawasan yang luas. Saya akan melihat balek semua kontribusi dan melakukan beberapa kajian sebelum memberikan draf Undang-undang kepada Konsel yang saya harap dapat diterima oleh masyarakat dan Konsel.

Dari segi pengurusan sampah, sampah yang lama adalah masalah besar bagi pulu dan termasuk asbestos yang telah di buang di hutan, dibiarkan keliling atau ditanam. Presiden Konsel telah menulis surat minggu ini kepada Yang Berhormat Tanya Plibersek Minister untuk environment meminta sokongan dari Komanwel untuk mengangkat sampah ini dari pulu.

Saya memohon maaf atas kesilapan karena tidak meletakkan halaman penuh yang menunjukkan semua ongkos dan bayaran pengurusan sampah tahun 2023 – 2024 di Atoll (dua edisi lalu), list lengkap di letak di sini untuk informasi anda.

Dengan tidak adanya ferry selama beberapa minggu, anda mungkin melihat pengurangan serbis tetapi kami akan berusaha untuk memastikan bin sampah anda kosong dan tempat sampah dibuka bila boleh.

Perancangan Masa Depan: Shire memainkan tugas besar dalam masa depan Pulu Cocos tetapi kami hanya sebaik perancangan yang menyokong proses kami. Setelah berada di sini selama lebih 12 bulan, sekarang saya mula tahu arah angin bertiup dan matahari jatuh.

Adalah menjadi keinginan saya untuk menetapkan arah dan masa depan dalam hal perancangan jangka panjang dan pendek dengan sokongan penuh dari Konsel yang baru (selepas undian October) dan seluruh masyarakat. Saya akan mengadakan hari perancangan masyarakat (Kampong dan Pulu Panjang) di Home Island pada bulan November untuk menetapkan tempo masa depan. Antara sekarang dan nanti saya akan menyiarkan berita dan surat keterangan kepada dokumen Shire untuk anda ketahui dan ingat.

Boat Ramp: Tahniah kepada Pete McCartney dan group boat ramp yang bekerja untuk memastikan ada boat ramp yang boleh di gunakan di Pulu Panjang. Sangat menyenangkan melihat inisiatif seperti itu dan sedikit tenaga yang dimasukan masyarakat akan sangat bermanfaat dan dari pandangan Shire, kami akan bekerjasama dengan kumpulan itu. Kami menyedari keperluan untuk boat ramp yang sesuai untuk sepanjang tahun untuk sekoci rekreasi dan emerjensi. Kami masih menyiasat kemungkinan untuk Komanwel bantu mengongkoskan boat ramp dan Presiden Konsel minggu ini telah menulis surat kepada Minister untuk Emergency Management Hon Murray Watt dan Minister untuk Transport Hon Catherine King untuk mendapatkan bantuan. Kami perlukan semua agensi termasuk AFP, Parks, Tourism, CRC, CMC, penduduk dan pembayar rates dan tourists untuk bekerjasama dan menyokong Shire dalam usaha kami untuk mendapatkan bantuan keuangan.

Sangat susah untuk faham bahawa Minister untuk Territories, Hon Kristy McBain, yang merupakan memba tempatan untuk bagian Eden Monaro, gagal menyokong boat ramp di Pulu Panjang. Bagian Eden Monaro mempunyai hubungan yang baik dengan lautan terutamanya, perikanan rekreasi dan komersial yang menggunakan ramp di sepanjang pantai timur Australia di kawasan pengundinya. Saya hanya boleh bayangkan kehebohannya kalau boat ramp di Eden terutup pasir setebal 3 meter dan tidak boleh digunakan!!!!!

Presiden Konsel juga telah menulis kepada Minister untuk mendapatkan sokongan yang telah ditolak dengan tegas pada masa lalu. Untuk menyokong Pete dan kumpulan pembantunya dan untuk menyampaikan suara yang keras dan jelas dari Cocos, Pete dan saya akan membuat petisyen masyarakat pada minggu depan untuk menambah sokongan kepada pertengkaran kami untuk mengongkoskan boat ramp. Kalau anda mempunyai idea mengenai perkara ini, sila jumpa Pete atau saya sendiri.

Berita Projek Runway: Sebagai CEO, mewakili Shire, minggu ini saya menghadiri pertemuan dengan AECOM, Fulton Hogan, dan Department of Defence Property Management untuk menjelaskan beberapa masalah kecil dan mendapatkan berita terbaru tentang kemajuan projek ini. Kontraknya belum keluar dan masih dalam perundingan di Canberra. Namun perencanaan untuk projek tersebut masih berjalan dan ada harapan kehadiran kontraktor yang terlihat pada akhir tahun dengan Material Off Load Facility yang akan mulai beroperasi di awal tahun baru.

Pelan pengurusan trafik untuk Pulu Panjang belum dibuat dan Fulton Hogan akan memberikan informasi kepada Shire untuk kasitahu masyarakat mengenai pengaturan jalan untuk projek tersebut - setelah memastikan penyelesaian dengan Main Roads dan Defence.

CHARMAP jelas merupakan kumpulan pekerjaan yang sangat besar dan pada saat ini untuk membantu Shire dengan sewa atas 2 bagian tanah kecil, pada saat ini, Defence Properti akan menyusun surat kepada Shire mengenai pendekatan mereka terhadap pertimbangan CHARMAP.

Seiring kemajuan perundingan kontrak, hal-hal akan berjalan sangat cepat dengan projek sehingga pertemuan rutin dengan kumpulan pengurusan projek akan berlaku supaya informasi boleh disampaikan kepada masyarakat.

Undian Lokal Government: Undian Lokal Government semakin dekat dan akan diadakan pada 21 October 2023, calon akan ditutup pada 7 September 2023. Shire akan mengadakan

undian extraordinary untuk 1 calon untuk selama 2 tahun dan undian biasa untuk 3 calon untuk selama 4 tahun. Ini adalah peluang besar bagi sesiapa yang berminat untuk bersuara tentang masa depan Pulu Cocos dan arah strategi Shire. Sesiapa yang ingin membincangkan tentang perkara yang terlibat sila hubungi saya atau menghadiri sesi online atau hadiri salah satu sesi masyarakat yang sedang dirancangkan. Website kami juga ada detail undian dan informasi untuk bakal calon.

Penutupan Jalan: Sudah tiba masanya lagi dimana ayer besar dan ombak lebih besar dari biasanya mengakibatkan banjir yang membuat jalan ditutup terutamanya jalan menuju selatan di Pulu Panjang. Ayer pasang besar dan ombak besar baru baru ini menyebabkan kerusakan besar pada jalan dan jalan south end perlu ditutup untuk dibetolkan dalam waktu yang tidak lama lagi. Keputusan untuk melakukan ini tidak diambil dengan mudah dan seperti yang telah kita setujui sebelumnya, jika ada yang perlu pergi ke south end ketika jalan ditutup, mereka harus kirim saya emel <u>frank.mills@cocos.wa.gov.au</u> untuk meminta izin dan alasannya.

Kami akan letak sign jalan ditutup di south end road, board di club dan di media social untuk informasi. Kepada kite surfers dan tourists, saya mohon maaf di atas sebarang kesulitan tetapi setiap tahun kerosakan jalan kami semakin teruk dan penutupan adalah satu keperluan untuk mengembalikannya kepada standard yang selamat.

Presiden Konsel menulis surat minggu ini kepada Yang Berhormat Chris Bowen Minister bagian climate change dan Yang Berhormat Senator Assistant Minister McAllister meminta sokongan dari Komanwel untuk melakukan pekerjaan perbaikan dan mengurangkan kerusakan lebih lanjut.

Public Waste Collection Sheds/Bins /Containers Permit and Clean up of Council Reserves, Streets or Public Places from Associated Littering or Illegal Dumping.

Unauthorised use of reserves, streets and street verges. Clean up fee for any residual matter, waste or unwanted materials including soils, tyres, oils, solid or liquid chemicals, household hazardous waste, asbestos, any light globe, chemicals of any nature, sand, vegetative materials, plastics, metals, furniture, bedding, dothing, household products, white goods, electronic products, cardboard, newspaper and magazines and any other product whatsoever left on any reserves, streets including verges, or other public places without approval of Council shall be charged a fee for the full cost of a clean up including treatment and any disposal costs. Does not preclude any other charges/penalties that may apply in accordance with other legislation.

Where a culprit can be identified, Private Works fees and charges will apply for the collection and processing of illegally dumped waste as well as the applicable Transfer Station Gate Fee. The Private works Fee will be based on staff and employees time and equipment to clean the site and treat and dispose of the matter as required. A minimum fee of 2 hours will apply.

Drink Tap Water Project Update

The Drink Tap Water project commenced several years ago, initiated by the Shire with support from the WA Department of Water, Environment and Regulation, the Commonwealth and Water Corp.

The intent of the project is to remove single use bottled water from the waste stream as a means of reducing waste management and incineration costs. The project, which included community surveys and engagement with business in 2020, has resulted in the installation of public water fountains and distribution of steel drink bottles.

The next step in this project is the development of a Local Law to ban the sale of single use water bottles with a volume of less than 5 Litres.

We are now seeking any further feedback or comments from community members and businesses regarding this initiative.

Fisheries Management at Cocos: An update from Cocos Marine Care

Thank you to everyone who attended our fisheries management update session last week!

In case you missed it, we're excited to share the latest developments in our ongoing effort to ensure the sustainability of Cocos (Keeling) Islands' fisheries resources.



New management approach

Over this past year, we have undergone a big shift in how our fisheries are managed, to a more communitydriven approach. As part of this model, the Department of Infrastructure has provided funding through the Shire to Cocos Marine Care, our local fisheries management body.

Part of Cocos Marine Care's role is to serve as the very first CKI Fisheries Advisory Committee (FAC). This committee formally represents the community's interests and perspectives and provides valuable advice to the Minister on fisheries matters at Cocos.

Cocos Marine Care will continue to work hand in hand with Sea Country Solutions, who offer technical guidance and support to ensure our fisheries continue to be managed sustainably.

This innovative model recognises the strong connection between the Cocos community and our unique marine environment. It also helps ensure we are a continuing part of our ocean's management.

The science behind sustainable fisheries

Our Fisheries Ranger, Shak, continues to collect valuable fisheries data. This includes information about what people are catching, where they are fishing, and the amount of fish being taken off island. Over the last 18 months, Shak has collected data from over 1100 fishing trips and measured more than 2000 fish! This critical data helps us to monitor fishing impacts and ensure our management is effective.

We will continue to work with Dr Jeremy Prince, a fisheries scientist with 40+ years working with coastal communities to assess and manage their fisheries. Dr Jeremy will be back in October to collect essential biological data on key species, including finfish and kima (clams). These data are instrumental in assessing the health of our fish stocks, which forms a core part of our fisheries management programme.

We also welcome a new member to our team – Osman Macrae. Ossie will be helping to collect fisheries data, as well as providing research support for many of the marine park grant projects.

Building strong foundations for the future

A key focus for this past year has been making sure everyone knows about the fishing rules and why we have them. Over the next few months, you can expect to see new rules brochures and signs at boat ramps, ensuring everyone is well-informed about responsible fishing practices.

While our main goal centres on education, it is important to make sure everyone is fishing sustainably and following the rules. *Please make sure you check the bag limits and size limits for the species you are targeting before you head out!*

They used the microscope to look at the insects they had collected. They found beetles, spiders, cockroaches with prickly legs and even some tiny green grasshoppers. This gives us an idea of what the buff banded rails might be eating on Direction Island.

With Pak Qoid, they learnt about which sea creatures are found in the marine park and which habitats they like, and finished with their favourite game "Siddiq's fish bingo".

A Code of Conduct for certain health care workers now protects consumers in the IOT who use services from unregulated health practitioners.

Examples of health care workers covered by the new Code of Conduct include dietitians, doulas, speech pathologists, social workers, naturopaths, massage therapists and other types of allied, alternative and community health services.

The Code of Conduct will apply to health care workers who are not required to be registered through the Australian Health Practitioner Regulation Agency (AHPRA). Similar to AHPRA, HaDSCO will issue public statements and prohibition orders to make people aware of non-compliant practitioners.

Conditions can be placed on a healthcare worker's practice where their conduct presents a serious risk to public health and safety and penalties of \$30,000 can apply.

The new Code of Conduct contains 17 clauses that outline how health care workers should undertake their practice, and The Health and Disability Service Complaints Office (HaDSCO) are responsible for investigating breaches of the Code of Conduct. 





Cocos "Feel Good" Story

Changing of The Guard

I'd like to tell you about a young Cocos Malay man called Siddiq, who I am fortunate enough to work with. I first met him in 2009, when he was a primary school student on Home Island. I often visit the school to run environmental education classes. He was the quiet student with a good head of hair, that asked thoughtful questions. He is pictured in the middle in Photo 1 in the black and yellow T shirt, peeking out from his peers, subtle and unassuming but taking it all in. This picture is taken in 2011, at a turtle education session hosted by Drs Scott and Andrea Whiting, whom Parks Australia has contracted for many years to monitor the green and hawksbill turtle populations here on Cocos.

This week Scott and Andrea are back on Cocos undertaking health assessments of the Cocos turtles. Like in the old days, they have hosted several education sessions with the school students and local community. This year, it is not a primary school aged Siddiq who is watching from the crowd, but rather a grown man who is employed by Parks Australia who is confidently assisting Scott, to measure, weigh and assess turtle health (See Photo 2).

I believe this is what you call "changing of the guard". Siddiq has chosen a career in conserving the Cocos environment and is now educating the young Cocos Malay children about their sea creatures, just like he was taught many years ago. Siddiq is a valued member of the Parks Australia team and a great role model for the youth and children of Cocos.
