



From the CEO's Desk 27 January 2023



Shire of Cocos (Keeling) Islands Chief Executive Officer Frank Mills

Happy New Year and welcome to 2023 everyone. This calendar year will prove to be an exciting and challenging one for the residents of the Shire and the elected members of Council. Your Council will be determining and resolving unprecedented challenges as they address legacy issues that should have been dealt with over the past 40 years. The Land Trust, land tenure, planning and CHARMAP and waste management are all on the agenda for this year.

As mentioned in previous editions of the Atoll, this year in setting the 2023 – 2024 budget, the Shire is going through a process of total review of waste management in line with the Indian Ocean Waste Management Strategy. From this we will be bringing in some controversial yet necessary changes to transfer station operations commencing 01 March 2023. More detail will be posted in future editions of the Atoll, social media, and our website. We will also be reviewing our schedule of fees and charges to reflect true cost of waste management in line with our 2023 – 2024 budget. We will hold community consultations on both West and Home Island as we get to the pointy end of the review.

Transfer Station Update: At Councils ordinary meeting for November the decision was made that commercial, industrial and all non-putrescible household waste will no longer be accepted at the Shire transfer stations from the 1st of March 2023. This temporary measure will ensure the Shire can determine a set of fees and charges that will accurately reflect the cost to process and dispose of these items off island. Fees and charges are envisaged to be implemented from 1 July 23 for all items requiring disposal off island.

The following items that will no longer be accepted include:

- Tyres
- Whitegoods
- Electrical items
- Metal or steel
- Mattresses
- Batteries
- Commercial waste

- Solar panels
- Paint
- Vehicles
- Demolition and construction waste
- Light globes
- Printer cartridges

The below is a list of items that will be accepted. These items can be placed in your green rubbish bin or taken to the transfer station during opening hours.

- Household plastic packaging items e.g., shampoo, deodorant, cleaning, soft plastic
- Juice and milk cartons
- Kitchen waste

- Nappies and wipes
- Paper
- Plastic, tin and steel food and drink packaging
- Polystyrene
- Sanitary products
- Textiles and clothing
- Cardboard
- Cooking oil

Recycling will continue as normal. Please remember only aluminium cans are to go in the yellow bins and glass in the red bins.

Our review of commercial leases is all but complete, relevant documents will be tabled at the February 2023 Ordinary meeting of Council for final approval. We will then be able to transfer all our current commercial leases over to correct documentation for signing by lessee's. There is still considerable work to be done regarding household leases and tenancies on Home Island and this will progress through the first quarter of the year. With the Shire Local Planning Scheme and the CHARMAP review and upgrades still happening, we hope to have these complete towards the end of this calendar year. Further community consultations will be held at appropriate times prior to their completion and approval by Council. As these plans will underpin any proposed development for the Cocos (Keeling) Islands the final plans will have a big bearing on our future. No new commercial leases will be considered until both these plans are finalized and approved by Council.

As this edition goes to print, the West Australian Electoral Commission, has closed nominations for the holding an extraordinary election to replace to two Councillors that have resigned. At the close of nominations, only one nomination was received – Signa KNIGHT and he will be automatically elected to Council up until the October 2023 Council elections. Council will now determine if one vacancy will remain until October 2023, or another attempt will be made to receive nominations and possible hold an extraordinary election.



Renovation and upgrade of the Retail Centre on Home Island is full swing and with our limited number of Council staff they are doing a great job to get the project finished as soon as possible.





The southern end of West Island had the road closed for a short period during high tides in January and with the high tides decreasing in HAT over the next couple of months, hopefully this will be the last closure for a while. Sandbagging works continue to be carried out on West Island and subject to Commonwealth Government funding will continue until all damage and mitigation works required from the August 2022 tidal surges and inundation are complete.

With the likelihood of commencement of the AIR 555 Forward Air Defence Base in the first quarter and the runway upgrade expected to commence mid-year, the estimated 500-million-dollar plus projects will see life change dramatically especially for the residents of West Island. Doubling the population of West Island en masse is sure to be a life changer and the Shire is working with project management to make the transition as smoothly as possible. Whilst we are still waiting for traffic

management plans for both projects, it should be noted, we have insisted residents receive priority for road use during the period of the projects.

In looking forward, the date of 06.04.2024 is the 40th anniversary of the vote for the Cocos Malay people to integrate into Australian society. Over the past six months, we have uncovered some very complex issues outlined in documentation between the Cocos Malay and the Australian Labour Government for events during the period surrounding the vote for integration on 06.04.1982. Documentation with respect to the rights and land tenure of the Cocos Malay people have been identified. On the face of it, there seems to be a need for interpretation of some document contents as some intent and commitment from the Commonwealth has gone missing over the past 39 years. The Shire has engaged a Perth legal service to assist in investigating the legality of some of the documents and we have requested the Commonwealth to work in a bipartisan role with the Shire for this.

Congratulations to the Award Recipients at the Australia Day celebration on Direction Island. It is great to see people being nominated for awards, but it is even better to be able to acknowledge the nominations at an awards ceremony, well done everyone. A big thank you to Adim and his small team for arranging the day and to all those who helped out organizing such a successful function.





Lastly, one to keep in mind, this year we (i.e., the Shire) is going to arrange a Home and West Island community wide celebration to recognize the end of Ramadan and Eid. The function will be at the Community Centre on Home Island (above and below) and all community members of Home and West Island will be invited to attend. Further details will be provided in the next Atoll.

Selamat Tahun Baru dan selamat datang di tahun 2023. Kalenda tahun ini terbukti menjadi tahun yang menarik dan mencabar bagi masyarakat dan Komiti Konsel. Konsel anda akan menentukan dan menyelesaikan cabaran yang belum pernah berlaku sebelumnya saat menangani masalah warisan yang seharusnya ditangani 40 tahun yang lalu. Land Trust, pemilik tanah, perancangan dan CHARMAP dan pengurusan sampah semuanya dalam agenda untuk tahun ini.

Seperti yang dinyatakan dalam Atoll yang sebelumnya, tahun ini dalam menetapkan budget 2023 – 2024, Shire sedang menjalani proses pemeriksaan semula pengurusan sampah untuk samakan dengan Strategi Pengurusan Sampah Indian Ocean. Dari ini kami akan membawa beberapa perubahan yang kontroversial tetapi perlu untuk menjalankan tempat sampah mulai 01 March 2023. Detail lebih lanjut akan disiarkan di Atoll yang akan datang, social media, dan website kami. Kami juga akan memeriksa kembali harga dan pembayaran untuk mencerminkan harga yang sebenarnya untuk pengurusan sampah sama dengan budget 2023 – 2024 kami. Kami akan mengadakan konsultasi masyarakat untuk Pulu Panjang dan

Kampong apabila kami sampai ke penghujung pemeriksaan.

Berita terkini Tempat Sampah: Pada mitingan Konsel pada bulan November keputusan telah dibuat bahawa sampah komersial, industrial dan sampah yang tidak boleh busuk tidak akan diterima di tempat sampah mulai 1 haribulan March 2023. Tindakan sementara ini akan memastikan Shire boleh menentukan harga dan pembayaran yang akan menggambarkan harga yang tepat untuk proses dan membuang barang-barang ini di luar pulu. Harga dan pembayaran dijangka akan bermula dari 1 July 23 untuk semua barang yang perlu di buang di luar pulu.

Barang-barang berikut yang tidak akan diterima lagi termasuk:

- Barang elektrik
- Besi atau timah
- Bolsak
- Bateri
- Sampah komersial

Dibawah adalah barang-barang yang akan diterima. Barang-barang ini boleh di buang di bin yang hiju atau dibawak di tempat sampah masa jam buka.

- Plastik bekas barang rumah contohnya, shampoo, obat kelek, obat cucikan, plastik lembek
- Bok jus dan susu

Recycling akan diteruskan seperti biasa. Tolong ingat hanya belek ayer jerok yang di buang di bin kuning dan kaca di bin merah.

Pemeriksaan kami tentang sewaan komersial sudah siap, dokumen yang berkaitan akan dibawak di mitingan Konsel pada bulan February 2023 untuk disetujukan. Kami kemudian akan dapat memindahkan semua sewaan komersial kami ke dokumentasi yang betul untuk ditandatangan oleh penyewa. Masih banyak kerja yang perlu dibuat mengenai sewaan rumah dan penyewa di Kampong dan ini akan berlanjut hingga suku pertama tahun ini. Dengan Shire Local Planning Scheme dan pertimbangan dan pembagusan CHARMAP masih berlaku, kami berharap ini akan siap menjelang akhir tahun kalenda ini. Konsultasi masyarakat lebih lanjut akan diadakan pada masa yang tetap sebelum ia selesai dan disetujui oleh Konsel. Karena pelen ini akan menyokong setiap pengembangan yang dicadangkan untuk Cocos (Keeling) Islands pelen akhir akan mempunyai kaitan yang besar pada masa depan kami. Tidak ada sewaan komersial baru yang akan dipertimbangkan sampai kedua pelen ini diselesaikan dan disetujui oleh Konsel.

Saat Atoll ini dihantar untuk diprint, West Australian Electoral Commission, telah menutup pencalonan untuk mengadakan undian tambahan untuk menggantikan dua Komiti Konsel yang telah mengundurkan diri. Pada penutupan pencalonan, hanya satu pencalonan diterima – Signa KNIGHT dan dia akan dipilih secara otomatik sebagai Komiti Konsel hingga undian Konsel pada bulan October 2023. Konsel sekarang akan memastikan apakah tempat kosong yang satu dibiarkan sehingga bulan October 2023, atau cobak sekali lagi untuk mendapatkan pencalonan dan kemungkinan mengadakan undian tambahan.

Pembetulan dan pembagusan Kede Kecil di Kampong berjalan lancar dan dengan jumlah pekerja Konsel yang terbatas mereka melakukan pekerjaan yang baik untuk menyelesaikan projek ini secepat mungkin.

Jalan southem end Pulu Panjang telah ditutup untuk masa yang pendek selama ayer besar di bulan January dan dengan ayer besar yang menurun di HAT selama beberapa bulan yang akan datang, semoga ini menjadi penutupan terakhir buat sementara waktu. Pekerjaan sandbagging terus dilakukan di Pulu Panjang dan bergantung atas bantuan Kerajaan Komanwel akan diteruskan sehingga semua kerusakan dan cara untuk mengatasi nya yang diperlukan dari bulan August 2022 siap.

Dengan kemungkinan permulaan AIR 555 Forward Air Defence Base pada suku pertama dan pembagusan runway yang diharapkan akan dimulai tengah tahun, projek yang dikira bernilai 500-juta -dolar lebih akan melihat kehidupan berubah secara mendadak terutama bagi penduduk Pulu Panjang. Menggandakan populasi Pulu Panjang yang banyak pasti akan mengubah hidup dan Shire bekerja sama dengan projek management untuk melakukan transisi selancar mungkin. Sementara kami masih menunggu pelen traffic management untuk kedua projek, perlu diingat, kami telah menegaskan penduduk diberi keutamaan untuk mengunakan jalan selama tempoh projek.

Dalam melihat ke hadapan, hari bulan 06.04.2024 adalah anibersari yang ke 40 tahun dimana orang Melayu Cocos mengundi untuk bersatu dengan Australia. Sepanjang enam bulan yang lalu, kami telah menemui beberapa masalah yang sangat kompleks yang digariskan dalam dokumentasai antara Melayu Cocos dan Australian Labour Government untuk acara dalam tempoh sekitar undian untuk bersatu pada 06.04.1982. Dokumentasi berkenaan dengan hak dan pemilikan tanah orang Melayu Cocos telah dikenal pasti. Pada pandangannya, nampaknya terdapat keperluan untuk menafsirkan beberapa isi dokumen karena beberapa niat dan janji dari Komanwel telah hilang sejak

39 tahun yang lalu. Shire telah melibatkan serbis hukum Perth untuk membantu menyiasat kesahan beberapa dokumen dan kami telah meminta komanwel untuk bekerja sama dengan Shire untuk ini .

Tahniah kepada Penerima Anugerah pada perayaan Australia Day di Pulu Tikus. Sangat menyenangkan melihat orang-orang diangkat untuk penghargaan, tetapi lebih bagus dapat mengucapkan terima kasi kepada calon di majlis anugerah, tahniah kepada semua. Terima kasih kepada Pak Sha dan tim nya yang kecil yang sudah mengatur hari itu dan semua yang telah membantu mengatur acara yang berjaya.

Akhir sekali, satu yang perlu diingat, tahun ini kami (iaitu, Shire) akan mengadakan perayaan masyarakat Kampong dan Pulu Panjang untuk menghargai berakhirnya Ramadan dan Aidilfitri. Majlis akan diadakan di Community Centre di Kampong (atas dan bawah) dan semua masyarakat Kampong dan Pulu Panjang akan dijemput. Detail lanjut akan diberikan di Atoll berikutnya.

aluminum cans and tyres ready to be returned to the mainland. All items disposed of at the transfer station that cannot be safely burnt (all non-putrescible waste) needs to be loaded and returned to the mainland for processing and recycling.

The Shire have also recently completed the successful loading and removal of one full container of asbestos to the mainland. The Shire is now in the process of loading two more containers of asbestos ready to be removed off Island for safe disposal.

New vehicle infringements information update - Cocos (Keeling) Islands

In prior Community Notices, the Department of Transport advised that changes to vehicle transfer and licensing would be applied to Cocos (Keeling) Islands with the issuing of infringement notices for outstanding transfer debts or unregistered vehicles.

Please note, Transfer and Plate Infringement Notices will be issued from Monday, 13 February 2023.

Note: Vehicle examination fees will not be applied on Cocos (Keeling) Islands until an Authorised Inspection Station (AIS) service provider has been appointed.

Vehicle licence transfer

If you purchase a used IOT vehicle, you will be issued a vehicle licence transfer invoice (transfer fee and vehicle licence duty).

You have 28 days to pay the invoice. Failure to pay by the due date will result in an Infringement Notice being issued. Further costs may apply.

Vehicle licence

Where a Vehicle Licence and Motor Injury Insurance Policy has expired, you must either renew the licence immediately or return the number plates to the MVR within three months of the vehicle licence expiry date.

Failure to do so will result in the issue of an Infringement Notice and further costs may apply. You must not drive your vehicle if the vehicle licence is expired.

Sold a Vehicle?

Have you sold a vehicle in the last 15 months and submitted a MR9 form (Notification of Change of Ownership) to the MVR? If not, the vehicle may still be registered in your name and you may receive a Plate Infringement if the vehicle registration has expired. Please contact the MVR to check.

Defect Notice (also known as a yellow sticker or work order)

Work Order Infringements started being issued from 3 January 2023.

If a Defect Notice is placed on your vehicle, you are required to comply with the requirements of the notice to avoid being issued a Work Order Infringement.

How can you avoid being issued an infringement?

- Pay outstanding vehicle licence transfer fees.
- If it has been less than three months since your vehicle licence expired and you wish to renew the licence, you should attend the MVR and pay the required fees.
- If it has been more than three months since your vehicle licence has expired, your vehicle will need to pass an examination before you can pay the required fees to renew the licence. You can pay for an examination at the MVR.
- If you choose not to register your expired vehicle licence, return the vehicle plates to the MVR.
- If you are unable to locate the vehicle plates, please attend the MVR and fill out a VL14 Lost/Stolen Number Plates Notification form.
- If your vehicle has been issued with a Defect Notice (yellow sticker or work order), return the vehicle plates to the MVR or have the defects fixed and arrange to have your vehicle examined through the MVR.

Indian Ocean Territories Health Clinic would like to welcome new residents to Cocos Islands.

The health service on Cocos is run by Indian Ocean Territories Health Service (IOTHS), we are a very small clinical team, there are currently health care workers, 2 nurses on West Island, 2 nurses on Home Island, and a Doctor who lives on Home Island.

The clinics are open 8am - 4pm, Monday to Friday.

Health staff also cover the islands for afterhours emergencies.

For emergencies on you can phone the on call mobile on West Island - 08 6102 5224.

For emergencies on you can phone the on call mobile on Home Island - 08 6102 8655.

You need to type all 10 numbers for these phone numbers

At times, the mobile reception fails on Cocos. If you are unable to get through on the mobile, please contact the clinic (West island: 9162 6655) (Home island: 9162 7609) and listen to the voice mail message for further instructions.

The nurses and doctor also carry a two-way radio at all times – you can contact us on **channel 24.** There is a radio at the clinics you are welcome to use. We ask that you specify which island you are on, when using the radios, so we know which on call nurse should respond to your emergency.

If you want after hours' advice, Cocos Islanders are encouraged to contact **Health Direct on 1800 022 222.** Health direct is available 24hrs a day, 7 days a week.



Health direct offer an excellent service, and can help when you are living remotely. Health direct can give advice on doses of medications recommended – we recommend having a supply of medications such as Panadol, Neurofen an antihistamine, suitable strengths for the occupants of your household. We also recommend keeping ice packs, bandaids, antiseptics and bandages in your house as first aid for personal use.

Coastal planning - get involved!

The Australian Government has partnered with the Western Australian State Department of Planning, Lands and Heritage and the Shire of Cocos (Keeling) Islands to develop a Coastal Hazard Risk Management and Adaptation Plan (CHRMAP) to understand how the Island coastlines will be affected by 'erosion' and 'inundation' and how to manage this into the future.

The project team were on-island in September and November 2022 to start engaging – and heard so much from many people in the community about your values for how you use the coastline.

The team is now using those values and the other information you shared with us to confirm technical work and refine the adaptation options being developed to manage risk into the future. We will be visiting again from 21 to 28 February 2023 to speak to you about these options and want to speak to as many people as we can to get your feedback about the work we have done.
