



From the CEO's Desk 02 June 2023



Council meeting: The Ordinary Meeting of Council for the month of May 2023 was held on 31 May 2023. Of particular interest to all residents will be:

• Council resolved for the month of June to recommence opening days and times of the transfer stations at current year prices for waste for the month of June 2023. This may take a couple of days to come into effect but it will provide an opportunity for anyone wishing to dispose of waste from their home prior to next financial years prices. Thank you to the West Island community members for being so forthright for this to occur and I am sure residents of both islands will welcome the move.

- Draft differential rates categories were agreed upon by Council and these will be
 posted at the Shire Offices on Home and West Island as well as the usual social media
 platforms and in the Atoll of course. Remember these are draft only and submissions
 are open until the 26th June 2023 at <u>info@cocos.wa.gov.au</u>
- In an innovative initiative, your elected members will be attending a workshop to discuss the Shire Leasing Policy, the Shire Trusts and the 1990 Memorandum of Association on Saturday the 3rd of June. This is a precursor to community consultations and survey and a visit by Civic Legal to discuss these matters with community on Home Island.

Waste Management: How pleasing to see so many of the West Island residents turn up at a meeting to discuss the introduction of a new fee structure for waste management in 2023 – 2024 financial year. Home Islanders it is your turn next and we will have a community meeting on Wednesday the 7th June 2023 at 6.30 p.m. and it would be great if we had someone from each household attend. An interpreter will be on hand to make sure everyone understands the discussions being had.

Good news is – recycle cans, Biosecurity and ABF have inspected and released the cans. No further treatment was required, and they were cleared to be collected. Hopefully this will pave the way for much more waste to be removed from the islands.

Proposed fees – the draft schedule of fees for transfer gate depositing of waste for 2023 – 2024 is as per below. Remember this is not official as the Council still needs to set the fees and charges for the next financial year.

E-waste and not for profit charges are still being considered and will be included in the next issue of the Atoll.

Community submissions regarding waste management will be received until 19 June 2023 at info@cocos.wa.gov.au so they can be channeled into consideration by Council at its meeting on 28 June 2023.

The policing of littering or dumping of waste is something that Council Rangers will be tasked with and in the event of prosecutions the assistance of the AFP may be available.

Boat ramps: West Island – my apologies to all the boat owners, fisherman, and watersports people and boat ramp users on West Island for the lack of activity regarding getting our boat ramp on West Island sorted out. There has been a lot of discussion behind the scenes that has come to an impasse and the Shire President and I will now be raising the boat ramp issue with the appropriate Minister when we are in Canberra during June. Despite the Minister for Territories Kristy McBain, recently advising that the boat ramp near the jetty belongs to the Shire, this is not the case. As we all know, the challenge for the Shire is maintenance and keeping the ramp clear of sand and this is the discussion we will be having in Canberra.


Runway Upgrade: Earlier this week, I attended a very informative meeting with AECOM, the Department of Defence and various other departments including the Department of Infrastructure, Transport, Regional Development, Communications and the Arts regarding the Runway Upgrade Project. Coming out of the meeting and of interest was:

- Funding for the runway upgrade has now been approved by the Parliamentary Works Committee and for the next few months AECOM will be in the process of getting contracts finalized so works can begin in the future.
- It is expected the Material Offload Facility works will commence at the back end of 2023 and be complete by around October 2024. Up to 30 workers will be involved in construction of this facility and they will be living in accommodation normally used for tourism.
- The accommodation camp will commence to be mobilized around mid-2024 after environmental approvals are complete.
- A recent survey of the Ports area will assist the Shire and the Commonwealth to be able to commit to leases over portions of land at the Port and Sydney Highway entering onto the airport.
- A traffic management Plan is being developed for Sydney Highway for the duration of the runway upgrade and the Department of Defence is waiting on advice from Transport WA before this is finalized.
- A CHARMAP solution as to the effects of the runway upgrade is still under development.
- AECOM and the Department of Defence will be developing a Disaster Management Plan in case of monsoonal or cyclonic activity during the project. This will feed into the Disaster Management Plan for the Cocos (Keeling) Islands.
- The Department of Defence will work with the Shire and other local businesses and organizations to maximize possible investment and economic opportunities locally.
- The next meeting with all parties will be in about 3 months and further updates will be provided then.

Miting Konsel: Miting Konsel untuk bulan May 2023 diadakan pada 31 hari bulan May 2023. Yang menarik bagi semua penduduk adalah:

• Konsel memutuskan pada bulan June untuk mulakan semula hari dan masa pembukaan tempat sampah dengan harga tahun sekarang untuk sampah bulan June 2023. Ini mungkin memakan waktu beberapa hari untuk berlaku tetapi ini akan memberi peluang kepada sesiapa yang ingin membuang sampah dari rumah mereka sebelum harga tahun keuangan berikutnya. Terima kasi kepada masyarakat Pulu Panjang yang sudah berterus terang untuk perkara ini berlaku dan pasti penduduk kedua-dua pulu akan menerima cadangan tersebut.

- Draf kategori perbezaan rates telah disetujui oleh Konsel dan ini akan di siarkan di Opis Shire di Kampong dan Pulu Panjang serta media sosial dan tentunya di Atoll. Ingat ini cuma acok-an dan pandangan dibuka sehingga 26hb June 2023 dan emel di info@cocos.wa.gov.au
- Dalam panduan kemajuan, memba konsel yang anda angkat akan menghadiri workshop untuk membincangkan Shire Leasing Policy, Shire Trusts dan 1990 Memorandum of Association pada hari Sabtu 3hb June. Ini adalah pendahuluan untuk perundingan dan survei masyarakat dan pelawatan dari Civic Legal untuk membincangkan perkara ini dengan masyarakat di Kampong.

Pengurusan Sampah: Betapa senangnya melihat begitu banyak penduduk Pulu Panjang yang hadir pada mitingan untuk membincangkan bayaran baru untuk pengurusan sampah pada tahun keuangan 2023 – 2024. Penduduk Kampong berikutnya giliran kalian dan kami akan mengadakan mitingan masyarakat pada hari Rabu 7hb June 2023 jam 6.30 malam dan sangat bagus jika ada salah satu orang dari setiap rumah yang datang. Akan ada orang untuk melayukan pembincangan ini, supaya semua dapat faham.

Berita baiknya adalah — belek ayer jerok yang di recycle, Biosecurity dan ABF telah memeriksa dan melepaskan belek tersebut. Tidak ada rawatan lanjut yang diperlukan, dan telah dilepaskan untuk di amek. Mudah-mudahan ini akan membuka jalan untuk lebih banyak sampah untuk dibuang dari pulu.

Bayaran yang dicadangkan – rancangan bayaran untuk membuang sampah untuk tahun 2023 – 2024 adalah seperti di bawah. Ingat ini belom rasmi karena Konsel masih perlu menetapkan caj dan bayaran untuk tahun keuangan akan datang.

Bayaran untuk E-waste dan bukan untuk keuntungan masih dipertimbangkan dan akan dimasukkan di Atoll yang akan datang.

Pandangan masyarakat mengenai pengurusan sampah akan diterima hingga 19 June 2023 di <u>info@cocos.wa.gov.au</u> supaya ia boleh di kasi untuk dipertimbangkan oleh Konsel di mitingan pada 28 June 2023.

Pengawal membuang sampah sembarangan adalah sesuatu yang akan ditugaskan oleh Ranger Konsel dan jika ada tuntutan bantuan dari AFP mungkin tersedia.

Boat Ramp: Pulu Panjang – mohon maaf kepada semua pemilik kolek, tukang mancing, dan orang-orang watersport serta pengguna boat ramp di Pulu Panjang karena kekurangan kerjaan untuk menyelesaikan boat ramp di Pulu Panjang. Terdapat banyak perbincangan di belakang yang menemui jalan buntu dan Presiden Konsel dan saya akan membawa masalah ini dengan Minista yang sesuai apabila kami berada di Canberra pada bulan June. Walaupun Minista untuk Territories Kristy McBain, baru-baru ini menasihatkan bahawa boat ramp dekat jetty adalah milik Shire, ini bukan kesnya. Seperti yang kita semua tahu, cabaran untuk Shire adalah menjaga dan memastikan ramp tidak terurup pasir dan perbincangan ini yang akan kami adakan di Canberra.

Runway Upgrade: Awal minggu ini, saya menghadiri mitingan yang sangat bermaklumat dengan AECOM, Department of Defence dan jabatan lain termasuk Department of Infrastructure, Transport, Regional Development, Communications and the Arts berkenaan Projek Runway Upgrade. Keluar daripada miting dan yang menarik ialah:

- Funding untuk runway upgrade telah diluluskan oleh Parliamentary Works Committee dan untuk berberapa bulan yang akan datang AECOM akan dalam proses menyelesaikan kontrak supaya pekerjaan boleh dimulakan pada masa hadapan.
- Diharapkan pekerjaan Material Offload Facility akan bermula pada ujung 2023 dan siap sekitar October 2024. Sehingga 30 pekerja akan terlibat dalam membuat fasiliti ini dan mereka akan tinggal di tempat tinggal yang biasanya digunakan untuk tourism.
- Camp tempat tinggal akan mula digerakkan sekitar pertengahan 2024 selepas persetujuan environmental selesai.
- Survei baru-baru ini di kawasan Ports akan membantu Shire dan Komanwel untuk menyewakan sebagian tanah di Port dan Sydney Highway yang masuk ke airport.
- Pelan pengurusan trafik sedang dibuat untuk Sydney Highway selama runway upgrade dan Department of Defence sedang menunggu nasihat dari Transport WA sebelum ini diselesaikan.
- Penyelesaian CHARMAP mengenai kesan untuk runway upgrade sedang dibuat.
- AECOM dan Department of Defence akan membuat Disaster Management Plan sekiranya berlaku musim hujan atau seklon selama projek berlangsung. Ini akan dimasukkan ke dalam Disaster Management Plan untuk Cocos (Keeling) Islands.

STATEMENT OF OBJECTS AND REASONS FOR DIFFERENTIAL RATE CATEGORIES 2023/2024

In accordance with section 6.36 of the *Local Government Act 1995 (WA) (CKI)* and the Council's "Notice of Intention to Levy Differential Rates and Minimum Payments", the following information details the objects and reasons for each of the proposed differential rating categories.

SUMMARY

The following are the proposed Differential General Rates and Minimum Payments for the Shire of Cocos (Keeling) Islands for the 2023/2024 financial year, to be effective from 1 July 2023.

Rate Category	2023/2024 Rate in Dollar (\$)	2023/2024 Minimum Payment		
General Developed	0.1202	\$780		
Vacant Land	0.2399	\$880		
Business	0.1268	\$780		

The above rate model is estimated to yield \$505,255 in rate revenue based on the information current at 30 April 2023.

WHAT ARE RATES?

Rates are a tax levied on all rateable properties within the boundaries of the Shire of Cocos (Keeling) Islands in accordance with the *Local Government Act 1995 (WA) (CKI)*. The overall objective of the proposed rates in the 2023/2024 Budget is to provide for the net funding requirements of the Shire's services, activities, financing costs and the current and future capital requirements of the Shire, after taking into account all other forms of revenue. The formulation of a rating system is about achieving a means by which Council can raise sufficient revenue to pay for the services it provides. Throughout Australia, the basis of using property valuations has been found to be the most appropriate means of achieving rating equity; however, the achievement of a wholly equitable rating system for all properties, in all areas, is a difficult task if it is based on the property valuations alone. For this reason, there are refinement options made available, such as differential rating, that the Shire of Cocos (Keeling) Islands has elected to use. For the Cocos (Keeling) Islands, land is valued by Landgate Valuation Services (Valuer General's Office – a Western Australian State Government agency) and those valuations are forwarded to each Local Government. Two types of values are calculated - Gross Rental Value (GRV) which generally applies to urban, non-rural land; and Unimproved Value which generally applies to rural land. The Shire of Cocos (Keeling) Islands only has properties valued on a GRV basis.

RATING PROVISIONS - LOCAL GOVERNMENT ACT 1995 (WA) (CKI)

The *Local Government Act 1995 (WA) (CKI)* sets out the basis on which differential general rates may be based as follows:

Section 6.32. Rates and service charges

(1) When adopting the annual budget, a local government -

a) in order to make up the budget deficiency, is to impose* a general rate on rateable land within its district, which rate may be imposed either –

(i) uniformly; or

(ii) differentially

DIFFERENTIAL RATES

Section 6.33. Differential general rates

(1) A local government may impose differential general rates according to any, or a combination, of the following characteristics —

(a) the purpose for which the land is zoned, whether or not under a local planning scheme or improvement scheme in force under the Planning and Development Act 2005; or

(b) a purpose for which the land is held or used as determined by the local government; or

(c) whether or not the land is vacant land; or

(d) any other characteristic or combination of characteristics prescribed.

(2) Regulations may -

(a) specify the characteristics under subsection (1) which a local government is to use; or

(b) limit the characteristics under subsection (1) which a local government is permitted to use.

(3) In imposing a differential general rate a local government is not to, without the approval of the Minister, impose a differential general rate which is more than twice the lowest differential general rate imposed by it.

(4) If during a financial year, the characteristics of any land which form the basis for the imposition of a differential general rate have changed, the local government is not to, on account of that change, amend the assessment of rates payable on that land in respect of that financial year but this subsection does not apply in any case where section 6.40(1)(a) applies.

(5) A differential general rate that a local government purported to impose under this Act before the Local Government Amendment Act 2009 section 39(1)(a) came into operation 1 is to be taken to have been as valid as if the amendment made by that paragraph had been made before the purported imposition of that rate.

MINIMUM PAYMENTS

Section 6.35. Minimum Payment

(1) Subject to this section, a local government may impose on any rateable land in its district a minimum payment which is greater than the general rate which would otherwise be payable on that land.

(2) A minimum payment is to be a general minimum but, subject to subsection (3), a lesser minimum may be imposed in respect of any portion of the district.

(3) In applying subsection (2) the local government is to ensure the general minimum is imposed on not less than -

(a) 50% of the total number of separately rated properties in the district; or

(b) 50% of the number of properties in each category referred to in subsection (6), on which a minimum payment is imposed.

(4) A minimum payment is not to be imposed on more than the prescribed percentage of -

(a) the number of separately rated properties in the district; or

(b) the number of properties in each category referred to in subsection (6), unless the general minimum does not exceed the prescribed amount.

(5) If a local government imposes a differential general rate on any land on the basis that the land is vacant land it may, with the approval of the Minister, impose a minimum payment in a manner that does not comply with subsections (2), (3) and (4) for that land.

(6) For the purposes of this section a minimum payment is to be applied separately, in accordance with the principles set forth in subsections (2), (3) and (4) in respect of each of the following categories -

(a) to land rated on gross rental value; and

(b) to land rated on unimproved value; and

(c) to each differential rating category where a differential general rate is imposed.

GROSS RENTAL VALUE (GRV)

Council has adopted differential rates in its Gross Rental Valuation area utilising the valuations supplied by the Valuer General (VG) for the following categories:

- GRV General Developed
- GRV Vacant Land
- GRV Business

The rates in the dollar are based on the general valuation as supplied by the Valuer General (VG) in respect of gross rental values (GRV's) effective from 1 July 2019. The Valuer General is required to maintain valuations of all rateable land in Western Australia for rating and taxing purposes. These values are assessed every three years by Landgate Valuers to complete what is known as a General Valuation. Every property is valued at a date set by the Valuer General and this is referred to as the Date of Valuation. Rating valuations are therefore assessed at a snapshot in time reflecting the property market for the local area at the same time. This ensures consistency and fairness in the allocation of rates.

The current GRV has a date of valuation of 1 August 2018. The GRV is determined by collecting rental evidence to determine the fair rental value for each property. The rental value for a house or other GRV property will be influenced by factors such as age, construction, size, car shelters, pools and location. As the GRV is currently assessed every three years, despite possible changes to the rental market, the GRV remains fixed until the next general valuation.

PROPOSED DIFFERENTIAL GENERAL RATES AND GENERAL MINIMUM PAYMENTS

Following are the objects and reasons for each of the differential rating categories and minimum payments for the 2023/2024 financial year.

GENERAL DEVELOPED

Characteristics

This category covers residential, special use and other properties where no commercial activity is occurring and is not being advertised as holiday accommodation.

Objects

The object of the rate for this category is to be the base rate by which all other GRV rated properties are assessed.

Reasons

The reason is that the other GRV rating categories have a higher demand on Shire resources and vacant land is encouraged to be developed.

The proposed rate in the dollar for this category is 0.1202, with a minimum payment of \$780.

GRV VACANT LAND

Characteristics

This category includes all properties that have no improvements other than merged improvements as defined in the Valuation of Land Act 1978.

Objects

The object of the rate for this category is to encourage landowners to develop residential vacant land and to reflect the different method used for the valuation of vacant residential land as compared to the GRV General Developed rate category.

Reasons

The reason is that the Shire wants to promote and encourage landowners to develop vacant land to its full potential, thereby stimulating growth.

The proposed rate in the dollar for this category is 0.2399, with a minimum payment of \$880.

GRV BUSINESS

Characteristics

This applies to properties zoned commercial and industrial or on all other properties where commercial activity is the main use or all or a portion of the property is being used as holiday accommodation.

Objects

The object of the rate for this category is to raise additional revenue to fund the costs associated with the higher level of service provided to properties in this category.

Reasons

The reason is that the Shire incurs higher costs to service these areas including infrastructure, landscaping and other amenities. In addition, extra costs are also associated with tourism and economic development activities that have a benefit to these ratepayers.

The proposed rate in the dollar for this category is 0.1268, with a minimum payment of \$780.

MINIMUM PAYMENT

The Shire proposes to impose following minimum payments for each differential rating category:

Rate Category	2023/2024 Minimum Payment

Vacant Land	\$880				
Business	\$780				

The object of the minimum payment is to ensure that all ratepayers make an equitable contribution to rate revenue, to provide for the net funding requirements of the Shire's services, activities, financing costs, and current and future capital requirements.

Submissions by ratepayers and electors in relation to the proposed differential rates may be made to council within twenty one (21) days and close 5pm on Sunday 26th June 2023.

Fines and enforcing fines V

These are short articles about legal issues that may interest you. They are not legal advice. You should always get individual legal advice for your situation.

This article will continue to look at ways that the Fines Enforcement Registry can take action for your fine debt if you have an unpaid fine. The two actions discussed in this article are not quite the same as the other enforcement options to recover the debt from you.

A fine expiation order will reduce or clear your fine. The publication of your details on FER's website does not enforce the fine. We will look at these two actions below.

Fine expiation order (reducing your fine by time spent in custody)

If you have been or are in custody (in gaol, on remand for a criminal charge that has not been finalised, or in police custody) and have unpaid fines, you can apply for a fine explaint order. A fine explaint order cannot apply to time spent in custody before 29 September 2020.

A fine explation order is an order that reduces your fine debt by a certain amount per day for each day spent in custody. It is often called "cutting out" the fine.

You make the application on the FER webpage. You will be told whether or not your application is successful and by how much your unpaid fine can be reduced.

The FER can make a Fine Expiation order if they think:

- You currently do not have the financial means to pay your fine debt and
- You currently do not have enough personal property that can be sold by the Sherriff under an enforcement warrant to pay your fine debt and
- If you are currently in gaol, it is unlikely that you will be able to pay your fine or have enough personal property to be sold by the Sherriff under an enforcement warrant to pay your fine debt within a reasonable time after you leave gaol or
- If you were previously in gaol but have been released and you make an application for a Fine Explation order, it is unlikely that you will be able to pay the fine debt or acquire enough personal property to be sold by the Sherriff under an enforcement warrant to satisfy your fine debt within a reasonable time.

The Fines Enforcement Registry can publish your details about your fine on its website

In certain circumstances the FER may publish details about you and your fine debt on its website if the time limit within which the fine must be paid (28 days) has expired.

The FER can publish details about you on the Registrar's website. The details that can be published include your full name, your address, whether there are outstanding registered fines and how much you owe in total. There are some other details they can publish.

The FER cannot publish any details if:

- you have a time to pay order,
- are appealing the fine to the court or
- you have been given a stay of execution on an enforcement warrant.

The FER also cannot publish any details if:

- you are under 18 years old
- you are a person protected under a violence restraining order or police order
- if publication might put you in danger, or
- if an existing court order made in the court proceedings where the fine was imposed says that the details cannot be published.

If your details are published on the website, the FER must remove your details as soon as possible from the website after you pay the outstanding amount.

Denda dan penguatkuasaan denda V

Ini adalah artikel pendek mengenai perkara undang-undang yang mungkin menarik untuk anda. Ini bukan nasihat undang-undang. Anda mesti selalu mendapatkan nasihat undang-undang sendiri untuk keadaan anda.

Artikel ini akan terus melihat cara Fines Enforcement Registry boleh mengambil tindakan untuk hutang denda anda jika anda menpunyai denda yang belum dibayar. Dua tindakan yang dibincangkan dalam artikel ini tidak sama dengan pilihan penguatkuasaan lain untuk mendapatkan semula hutang dari anda.

Perintah penebusan denda akan mengurangkan dan menghabiskan denda anda. Mengeluarkan detail anda di website FER tidak menguatkuasakan denda. Kami akan melihat dua tindakan ini di bawah.

Perintah penebusan denda (mengurangkan denda anda dengan masa yang dihabiskan dalam tahanan)

Jika anda pernah atau berada dalam tahanan (dalam kurungan, dalam tahanan untuk tuduhan kriminal yang belum diselesaikan, atau dalam tahanan polis) dan ada denda yang belum dibayar, anda boleh memohon untuk mendapatkan perintah penebusan denda. Perintah penebusan denda tidak boleh digunakan untuk masa yang dihabiskan dalam tahanan sebelum 29 September 2020.

Perintah penebusan denda adalah perintah yang mengurangkan hutang denda anda dengan jumlah tertentu setiap hari untuk setiap hari yang dihabiskan dalam tahanan. Ini sering dipanggil "memotong" denda.

Anda buat permohonan di halaman web FER. Anda akan di kasitahu sama ada permohonan anda berjaya atau tidak dan berapa banyak denda yang belum dibayar boleh dikurangkan.

FER boleh membuat perintah Penebusan Denda jika mereka fikir:

- Anda saat ini tidak mempunyai kemampuan keuangan untuk membayar hutang denda anda dan
- Anda saat ini tidak mempunyai harta peribadi yang mencukupi yang boleh dijual oleh Sherriff di bawah surat perintah penguatkuasaan untuk membayar hutang denda anda dan
- Jika saat ini anda ada dalam kurungan, kemungkinan besar anda tidak akan dapat membayar denda anda atau mempunyai harta peribadi yang cukup untuk dijual oleh Sherriff di bawah surat perintah penguatkuasaan untuk membayar hutang denda anda dalam masa yang wajar selepas anda keluar kurungan atau
- Jika sebelum ini anda berada dalam kurungan tetapi telah dibebaskan dan anda membuat permohonan untuk perintah Penghapusan Denda, tidak mungkin anda akan boleh membayar hutang denda atau memiliki properti peribadi yang cukup untuk dijual oleh Sherriff di bawah surat perintah penguatkuasaan untuk membayar hutang denda anda dalam masa yang wajar.

Fines Enforcement Registry boleh mengeluarkan detail tentang denda anda di website mereka

Dalam keadaan tertentu FER boleh mengeluarkan detail tentang anda dan hutang denda anda di website mereka jika batas waktu pembayaran denda (28 days) telah berakhir.

FER boleh mengeluarkan detail tentang anda di website Registrar. Detail yang boleh dikeluarkan termasuk nama penuh anda, alamat anda, apakah ada denda diregista yang belum dibayar dan sebanyak berapa hutang anda. Terdapat beberapa detail lain yang boleh mereka keluarkan.

FER tidak boleh keluarkan detail apa pun jika:

- anda ada perintah masa untuk membayar,
- sedang merayu denda kepada mahkamah atau
- anda telah dikasi penangguhan pelaksanaan atas surat penguatkuasaan.
- FER juga **tidak boleh** keluarkan detail apa pun jika:
- anda berumur di bawah 18 tahun
- anda adalah orang yang dilindungi di bawah perintah penahanan kekerasan atau perintah polis
- jika publikasi boleh membahayakan anda, atau
- jika perintah mahkamah yang ada dibuat dalam proses mahkamah di mana denda dijatuhkan mengatakan bahawa detail anda tidak boleh disiarkan.

Jika detail anda di keluarkan/disiarkan di website, FER harus menghapus detail anda secepat mungkin dari website selepas anda membayar jumlah terhutang.

Covid Booster Immunisations

All adults can get a booster if it's been <u>6 months or longer since your last COVID-19</u> booster or confirmed infection (whichever is most recent) for additional protection against severe illness from COVID.

This is particularly recommended for people at higher risk of severe illness, including:

- everyone 65 years and over
- everyone 18 years and over with medical comorbidities, disability or complex health needs.
 - Children and young people aged 5 to 17 years can get a booster dose if:
- they have a health condition that put them at risk of severe illness, and
- if it's been 6 months since their last dose or COVID-19 infection.

The clinical team can help you decide if your child should receive a booster. Booster doses are not recommended at this time for children and adolescents under 18 years of age who do not have any risk factors for severe COVID-19.

Please register your interest by phoning the Home Island or West Island Clinic so we can book you in for your booster. Immunizations are available at both clinics. We will aim to book boosters in groups of 6 people to reduce wastage.

Influenza Immunisations

Influenza is a common disease of the respiratory tract. It affects people of all ages. Influenza is the most common vaccine-preventable disease in Australia. Although it can be a mild disease, it can also cause very serious illness in otherwise healthy people. It can require hospitalisation and can cause death.

COVID-19 vaccines can be co-administered (i.e. on the same day) with an influenza vaccine.

All Cocos Island residents aged 6months and over are Eligible for free Influenza Immunisation ongoing for the month of June.

Influenza Immunisations are available at both Home Island and West Island Clinics. Any further questions regarding immunisation – book an appointment with your GP or Nurse

Information about influenza (flu) disease, vaccines and recommendations for vaccination has been taken from the Australian Immunisation Handbook.

It is also known as Sea almond and the Malay name is Pokok Ketapang.

The fruit is a drupe long and broad, green at first, then yellow and finally red when ripe, containing a single seed.

The leaves are large, long and broad, ovoid, glossy dark green and leathery. They are dry-season deciduous; before falling, they turn pinkish-reddish or yellow-brown

The fruit is edible. Seeds are edible raw or cooked when ripe and tare small and difficult to extract.



DIY

Reusable Dryer Sheets

- Used dish towels or scraps of cotton cloth
- 1 cup distilled white vinegar
- 15-20 drops essential oil of your preference
- Scissors
- Sealable container

INSTRUCTIONS

- 1. Cut the towels into squares, about the size of your outstretched hand. Fold in thirds.
- 2. In a sealable container, add the vinegar and essential oil, then simply place your folded towels in so that one end of each touches the vinegar. They will automatically begin to soak up the mixture.

3. Keep the container sealed and simply select a towel or two to add to your dryer for each load.

4. When the container dries up and the towels have been used, simply add more vinegar and essential oil and put the towels back in!




