Waste Changes - Commencing Monday 14 March 2022

As directed by the Department of Water and Environmental Regulation, waste transfer stations on Home Island and West Island will be closed to unrestricted public access.

The sites will be open and managed during the following hours:

Monday – Friday: 7:00am – 9:00am Sunday: 3:00pm – 5:00pm

To reduce the need to access the transfer station, the Shire will be trialling an additional kerbside collection each week. Household collections on both Home Island and West Island will be undertaken:

Monday and Thursday

Sentencing III – what types of punishments the court can give you

These are short articles about legal issues that may interest you. They are not legal advice. You should always get individual legal advice for your situation.

This is the third of six articles about sentencing (where a court gives you a penalty) when you are convicted (found guilty) of a criminal offence. In this article we will first look briefly at the law about reductions in sentence if you plead guilty and the law about spent convictions. Then we will start to look at the penalties that the court can give you for state-based offences.

Reduction in sentence for plea of guilty

For sentencing for state-based offences, the law allows a reduction in your sentence if you plead guilty. This is to recognise that there are benefits to the government and to any victim or witnesses if you plead guilty instead of going to trial.

The earlier you plead guilty, the greater the reduction allowed. The court must say if it is reducing your sentence and by how much. If you are given a term of imprisonment, the maximum reduction allowed is 25% on what the court would otherwise have given you as your jail sentence. You can only be given the maximum reduction if you plead guilty or tell the court that you are going to plead guilty at the earliest reasonable opportunity. It is up to the court what reduction, up to the maximum, they allow for your plea of guilty.

Spent conviction order

The court can make a spent conviction order for less serious offences. This means that your conviction is wiped away and becomes "spent" (gone). There is a test that is applied. We have looked at spent conviction orders in other articles.

We will now look at the penalties that the court can give you, from the least serious to the most serious penalty.

No punishment

If the court finds that the offence is trivial (not serious at all) or technical (strictly an offence but not very serious) the court can decide to not give you a penalty. It must find that it is not just (which means not fair or right) to give you a penalty, taking into account your age, previous behaviour and criminal record, mental health and various other things. It is only in rare circumstances that the court will decide not to give you a penalty.

Conditional release order (good behaviour bond)

A conditional release order (CRO) is also sometimes called "a good behaviour bond". It is an order that you be of good behaviour for a period of time and not commit any other offences. It can have other conditions put on it. You are <u>not</u> supervised by Community-based Corrections when you are on a CRO.

It is an offence if you breach (break) a condition of your CRO. If you are convicted of this offence (breach of requirement of a CRO) the court can do one of the following things:

- a) take no action
- b) fine you up to \$1,000 and may or may not take other action
- c) if you are still on the order, leave the order as it is, change the order, or cancel the order and give you a new sentence for the original offence for which you were given the order or
- d) if the order is already finished, give you a new sentence for the original offence.

Fine (money that you have to pay)

This is a very common penalty. A fine can also be suspended (see below). A fine must be paid within 28 days, or, within 28 days you must apply to the court for an order allowing you to pay the fine off by instalments.

When the court is deciding the amount of the fine you have to pay, it must take into account your ability to pay. But if the court has no information about your ability to pay, it can still give you a fine.

You can be given one fine only (called a global fine) where you have committed 2 or more offences if the same set of facts applies to the offences or where the offences are all part of the one incident.

If the fine is not paid, it can be enforced by the Fines Enforcement Registry. This can result in suspension of your driver's licence, cancellation of your vehicle licence, sale of your property or immobilisation of your vehicle.

Where the law states that the penalty is a fine only, you can instead be put on a community-based order or an intensive supervision order, which are discussed in the next article.

Suspended fine

The court can give you a fine but suspend it for a period up to 2 years. If during the period that it is suspended you commit any offence, you will have to pay your suspended fine.

Hukuman III – perkara yang boleh dilakukan oleh mahkamah sebelum memberi hukuman atas kesalahan anda

Ini adalah artikel pendek mengenai perkara undang-undang yang mungkin menarik untuk anda. Ini bukan nasihat undang-undang. Anda mesti selalu mendapatkan nasihat undang-undang sendiri untuk keadaan anda.

Ini adalah yang ketiga dari enam artikel tentang hukuman (dimana mahkamah memberi hukuman) apabila anda dihukum (didapati bersalah) atas kesalahan anda. Dalam artikel ini kami akan melihat secara ringkas undang-undang tentang pengurangan hukuman jika anda mengaku bersalah dan undang-undang tentang hukuman yang ditunda. Kemudian kami akan melai melihat hukuman yang dapat diberikan pengadilan kepada anda untuk pelanggaran daerah.

Pengurangan hukuman karena pengakuan bersalah

Untuk hukuman bagi kesalahan daerah, undang-undang membenarkan pengurangan hukuman anda jika anda mengaku bersalah. Ini untuk mengakui bahwa ada manfaat kepada kerajaan dan bagi mana-mana mangsa atau saksi jika anda mengaku bersalah dari pada di bawak ke pengadilan.

Lebih awal anda mengaku bersalah, lebih besar pengurangan yang dibenarkan. Mahkamah harus mengatakan jika ia mengurangkan hukuman anda dan berapa banyak.

Jika anda diberi hukuman penjara, pengurangan yang paleng banyak yang di bolehkan adalah 25% dari apa yang seharusnya diberikan mahkamah kepada anda sebagai hukuman penjara anda. Anda hanya boleh di kasi pengurangan yang paleng banyak jika anda mengaku bersalah atau memberitahu makamah bahwa anda akan mengaku bersalah pada kesempatan yang paleng awal. Terpulang kepada mahkamah pengurangan apa, sehingga yang paleng banyak, yang mereka izinkan untuk pengakuan bersalah anda.

Perintah hukuman yang ditunda

Mahkamah boleh membuat perintah hukuman yang ditunda untuk kesalahan yang kurang serius. Ini bermakna bahwa hukuman anda terhapus dan menjadi "tertunda" (hilang). Terdapat tes yang digunakan. Kami telah melihat perintah hukuman yang ditunda dalam artikel yang lain. Sekarang kami akan melihat hukuman yang boleh diberikan oleh mahkamah kepada anda, dari hukuman yang paleng ringan hingga yang paleng serius.

Tidak ada hukuman

Jika mahkamah mendapati bahwa kesalahan itu biasa (tidak serius langsung) atau teknikal (adalah satu kesalahan tetapi tidak terlalu serius) mahkamah boleh memutuskan untuk tidak memberi anda denda. Ia mesti dapatkan bahwa ia tidak cuma (yang bermaksud tidak adil atau betol) untuk memberi anda hukuman, dengan mempertimbangkan umur anda, tingkah laku dan rekod anda sebelomnya, kesehatan mental dan perkara lain. Hanya keadaan yang jarang berlaku untuk mahkamah akan memutuskan untuk tidak memberi anda hukuman.

Perintah pelepasan bersyarat (ikatan tingkah laku yang baik)

Perintah pelepasan bersyarat (CRO) jugak kadang-kadang di panggel "ikatan tingkah laku yang baik". Ini adalah perintah supaya anda berkelakuan baik untuk masa yang ditentukan dan tidak melakukan kesalahan lain. Ini boleh meletakkan syarat lain. Anda tidak diawasi oleh Community-based Corrections saat anda berada di CRO.

Adalah menjadi satu kesalahan jika anda melanggar (melanggar) syarat CRO. Jika anda dihukum karena pelanggaran ini (pelanggaran persyaratan CRO) mahkamah boleh melakukan salah satu daripada perkara berikut:

- tidak ambil tindakan
- mendenda anda hingga \$1,000 dan mungkin atau tidak mungkin mengambil tindakan lain
- jika anda masih dalam perintah, biarkan perintah itu seperti adanya, tukar perintah itu, atau batalkan perintah itu dan berikan anda hukuman baru untuk kesalahan asal yang mana anda telah diberi perintah atau
- jika perintah itu sudah selesai, berikan anda hukuman baru untuk pelanggaran asal.

Denda (uang yang harus anda bayar)

Ini adalah penalti yang sangat biasa. Denda boleh juga digantong (lihat di bawah). Denda mesti dibayar dalam tempoh 28 hari, atau, dalam tempoh 28 hari anda mesti memohon dengan mahkamah untuk perintah yang memungkinkan anda membayar denda secara instalment.

Apabila mahkamah memutuskan jumlah denda yang perlu anda bayar, ia mesti memperhitungkan kemampuan anda untuk membayar. Tetapi jika mahkamah tidak mempunyai informasi tentang kemampuan anda untuk membayar, ia masih boleh memberi anda denda.

Anda boleh dikasi satu denda saja (dipanggel denda global) di mana anda telah melakukan 2 atau lebih pelanggaran jika fakta yang sama digunakan untuk kesalahan atau dimana semua kesalahan adalah sebahagian daripada satu kejadian.

Jika denda tidak dibayar, ia boleh dikuatkuasakan oleh Fines Enforcement Registry. Ini boleh mengakibatkan lesen anda di gantong, lesen kereta anda di batalkan, penjualan property anda atau imobilisasi kereta anda.

Jika undang-undang menyatakan bahwa hukuman nya adalah denda sahaja, anda boleh diletakan dalam perintah masyarakat atau perintah pengawasan intensif, yang akan dibicarakan dalam artikel berikutnya.

Denda yang digantong

Mahkamah boleh memberi anda denda tapi digantong sehingga 2 tahun. Jika dalam tempoh penggantongan anda melakukan apa-apa kesalahan, anda harus bayar denda yang digantong.

Kami akan terus melihat hukuman yang boleh diberikan mahkamah kepada anda dalam artikel berikutnya.






Green Living Tips


