#### NOTICE OF COMMUNITY INFORMATION FORUMS

From 26-29 November 2022, the project team for the Department of Defence's Cocos (Keeling) Islands Airfield Upgrade Project will conduct Community Information Forums on Home and West Island to outline proposed future construction works on West Island.

Subject to Parliamentary Approval, the project will provide a significant upgrade to the existing infrastructure of the existing Cocos (Keeling) Islands airfield to enhance the overall safety and serviceability for all aircraft operating out of the islands. The proposed works will involve upgrades to the runway, taxiways, aprons and lighting, in addition to improving drainage to minimise future flooding on the runway.

The project also proposes to upgrade existing infrastructure on the island (including road works along the Sydney Highway) and to construct a new, permanent Material Offload Facility (construction wharf) at the Rumah Baru Port facility to enable construction activities to take place. The Project will also aim to remove some existing Defence legacy waste (aircraft debris) from West Island.

The Community Information Forums will include information, displays and a presentation outlining the proposed works and will also offer an opportunity for locals to ask questions and speak with members of the Project Team and Defence Representatives.

Tunduk pada Persetujuan Parlimen, projek ini akan memberikan peningkatan yang penting pada infrastruktur yang ada di lapangan terbang Cocos (Keeling) Islands untuk meningkatkan keselamatan dan kemudahan untuk semua kapal terbang yang beroperasi di luar pulu. Pekerjaan yang dicadangkan akan melibatkan membaguskan runway, taxiways, tempat kapal terbang menanti dan lampu, di samping itu membaguskan pipe buangan untuk mengurangkan banjir di runway di masa depan.

Projek ini juga bercadang untuk membaguskan infrastruktur yang ada di pulu (termasuk pekerjaan jalan di sepanjang Sydney Highway) dan membuat tempat untuk menurunkan cargo yang baru (jembatan untuk kerjaan) di Rumah Baru Port facility untuk pekerjaan di jalankan. Projek ini juga akan bertujuan untuk mengalehkan sampah Defence (sampah kapal terbang) dari Pulu Panjang.

Forum Maklumat Masyarakat akan termasuk informasi, pertunjukan dan presentasi menggariskan kerjaan yang dicadangkan dan juga akan menawarkan peluang kepada penduduk untuk bertanya dan bercakap dengan memba Tim Projek dan Wakil Defence.

#### What is bail? IV

These are short articles about legal issues that may interest you. They are not legal advice. You should always get individual legal advice for your situation.

This is the fourth article about bail. In this article we will look at what happens if you breach (break) your bail undertaking. We will also look at whether you can apply for bail again if you were refused bail on an earlier occasion and whether you can change your bail conditions.

#### If you breach (break) certain bail conditions you commit an offence

If you breach (break) certain bail conditions you commit a criminal offence. If you breach other bail conditions you do not commit a criminal offence but you can have your bail cancelled or your bail conditions changed.

You commit a criminal offence if you:

- Don't attend court when you are required to do so by your bail undertaking (unless you have a reasonable excuse)
- Did not attend court on the day you were required to and then don't attend court as soon as possible afterwards
- Breach any "protective" bail conditions (for example, conditions not to communicate with a person, not to approach a person or be within a certain distance of where they live or work or study)

As mentioned above, if you do not attend court when you are required to, this is an offence, unless you have a good reason for not attending court. You should bring evidence of the good reason to court. For example, if you were very sick and could not go to court, you should bring a medical certificate to court to show this. If you can persuade the court that you had a good reason for not coming to court on the day you were supposed to, you may avoid being charged with the offence of breach of bail.

If you have missed your court date, you must attend court as soon as you can after that. If you don't come to court as soon as you can, this is another offence. If you miss your court date you should try to go to court the next day.

If you breach bail by not attending court on your court date, you can be arrested and put into police custody until the police can take you to court. The police must take you to court as soon as possible.

The maximum penalty for the offence of breaching bail is time in prison of not more than 3 years and a fine of up to \$10,000.

The offence will appear on your history for court. If you are charged with an offence on a later occasion, and bail is being considered, the fact that you have previously been convicted of breaching bail will be taken into account in deciding whether you can be given bail. It may make it harder for you to get bail.

# If you breach (break) other bail conditions it is not an offence but you could have your bail cancelled or changed

If you breach (break) any of the other conditions attached to your bail undertaking (apart from the ones discussed above) you have not committed an offence but you may have your bail cancelled or changed.

Some examples of breaches of bail that are not criminal offences are not reporting to a police station when you are required to do so, or not obeying the curfew that has been put on you.

The court can cancel your bail (you then go into custody) or it can change your bail conditions.

#### Can I apply again if I am refused bail? Can I apply to change my bail conditions?

There are only certain situations where you can:

- apply for bail again if you were previously refused bail by the court or
- apply to change your bail conditions.

These situations are as follows:

- You did not present your case for bail properly on the earlier occasion when you were refused bail or given bail. An example might be if you applied for bail yourself and did not tell the Magistrate something important which would have persuaded the Magistrate to give you bail. Or you did not tell the Magistrate something important and you are put on bail conditions that you cannot comply with.
- New facts have been discovered, or there are new or changed circumstances since you were given bail or refused bail on an earlier occasion. An example might be if one of your bail conditions is to report to a police station 3 times per week, but you are admitted to hospital for a month. In these circumstances, you will probably be allowed to change your bail conditions.
- If you were given home detention bail and you have complied with it for a month or more. In these
  circumstances, you may be allowed to change your bail conditions.

In the fifth and final article we will look at some of the new changes to the Bail Act that started on 1 November 2022.

Jika anda melanggar syarat jaminan tertentu anda melakukan kesalahan kiriminal. Jika anda melanggar syarat jaminan lain anda tidak melakukan kesalahan kriminal tetapi jaminan anda boleh dibatalkan atau syarat jaminan anda ditukar.

Anda melakukan kesalahan kriminal jika anda:

- Tidak menghadiri mahkamah apabila anda diharuskan untuk melakukannya dengan jaminan anda (kecuali anda mempunyai alasan yang pantas)
- Tidak menghadiri mahkamah pada hari yang anda diharuskan dan kemudian tidak menghadiri mahkamah secepat mungkin selepas itu
- Melanggar syarat "pelindung" jaminan (misalnya, syarat untuk tidak bicara dengan seseorang, tidak merapat dengan seseorang atau berada dalam jarak tertentu dari tempat mereka tinggal atau bekerja atau belajar)

Seperti yang dibilang di atas, jika anda tidak menghadiri mahkamah ketika anda diharuskan, ini adalah satu kesalahan, kecuali anda mempunyai alasan yang pantas untuk tidak hadir ke mahkamah. Anda harus bawak bukti alasan yang baik ke mahkamah. Contohnya, jika anda sakit dan tidak dapat pigi ke mahkamah, anda harus bawak medical certificate untuk tunjukan ke mahkamah. Jika anda boleh menyakinkan mahkamah bahawa anda mempunyai alasan yang pantas untuk tidak hadir ke mahkamah pada hari yang seharusnya anda datang, anda boleh mengelak dari pada tuduhan kesalahan melanggar jaminan.

Jika anda keliwatan hari bulan mahkamah anda, anda harus hadir mahkamah secepat mungkin selepas itu. Jika anda tidak datang ke mahkamah secepat mungkin, ini adalah satu lagi kesalahan. Jika anda keliwatan hari bulan mahkamah anda, anda harus coba pergi ke mahkamah pada hari berikutnya.

Jika anda melanggar jaminan dengan tidak datang ke mahkmah pada hari bulan mahkamah anda, anda boleh ditangkap dan dimasukkan ke dalam tahanan polis sampai polis boleh bawak anda ke mahkamah. Polis harus bawak anda ke mahkamah secepat mungkin.

Hukuman paling besar untuk kesalahan melanggar jaminan adalah dikurung tidak lebih dari 3 tahun dan denda sebanyak \$10,000.

Kesalahan itu akan ada di rekod mahkamah anda. Jika anda di tuduh melakukan kesalahan di kemudian hari, dan jaminan sedang dipertimbangkan, fakta bahawa sebelum ini anda telah dihukum karena melanggar jaminan akan diperhitungkan dalam memutuskan apakah anda boleh dikasi jaminan. Ini mungkin mempersulitkan anda untuk mendapatkan jaminan.

# Jika anda melanggar syarat jaminan yang lain itu bukan kesalahan tetapi jaminan anda boleh dibatalkan atau ditukar

Jika anda melanggar salah satu syarat lain yang terikat pada jaminan anda (selain daripada yang dibincangkan di atas) anda tidak melakukan kesalahan tetapi jaminan anda boleh dibatalkan atau ditukar.

Beberapa contoh pelanggaran jaminan yang bukan kesalahan kriminal adalah tidak pigi buat repot di stesen polis apabila anda diharuskan melakukannya, atau tidak mengikut perintah ada dirumah waktu malam yang telah diletakkan kepada anda.

Mahkamah boleh batalkan jaminan anda (anda kemudian ditahan) atau boleh tukar syarat jaminan anda.

# Bolehkan saya memohon lagi jika jaminan saya ditolak? Bolehkah saya memohon untuk tukar syarat jaminan saya?

Terdapat keadaan tertentu di mana anda boleh:

- memohon jaminan sekali lagi jika anda ditolak sebelum nya oleh mahkamah atau
- memohon untuk tukar syarat jaminan anda.

Keadaan ini adalah seperti berikut:

- Anda tidak menyampaikan kes jaminan anda dengan betol pada masa yang lebih awal apabila anda ditolak ikatkan jaminan atau dikasi jaminan. Contohnya mungkin jika anda sendiri memohon jaminan dan tidak kasitau Magistrate sesuatu yang penting yang boleh meyakinkan Magistrate untuk kasi anda jaminan. Atau anda tidak kasitahu Magistrate sesuatu yang penting dan anda dikasi jaminan yang anda tidak boleh ikut.
- Fakta baru telah ditemukan, atau ada keadaan baru atau berubah sejak anda dikasi jaminan atau ditolak jaminan pada kesempatan sebelumnya. Contohnya adalah jika salah satu syarat jaminan anda adalah untuk repot ke stesen polis 3 kali seminggu, tetapi anda masok hospital selama sebulan. Dalam keadaan ini, anda mungkin akan diizinkan untuk tukar syarat jaminan anda.
- Jika anda dikasi jaminan tahanan rumah dan anda telah mengikutnya selama sebulan atau lebih. Dalam keadaan ini, anda mungkin diizinkan untuk tukar syarat jaminan anda.


