

STARTING A FOOD BUSINESS

The following information will help you to understand food laws that you need to comply with when getting started in the food industry such as running a food business from home.

Home based food businesses

Certain food businesses may operate from a residential house such as:

- B&Bs
- Food prepared for fundraising events
- Online food sales from home
- Preparing food for local markets

If you prepare food for sale or sell food in a residential home, you are deemed to be a food business under the *Food Act 2008*.

Therefore you must:

- Comply with all food laws and
- Register or notify your food business with the Shire.

Food Laws - legislation and standards

The purpose of food legislation and standards is to make sure that food for sale is safe and suitable to eat so that people don't get sick.

It is important that you understand and comply with food legislation before operating your business.

Registration of a food business

Before operating your food business, you need to register or notify your business with the Shire.

This includes temporary food businesses such as a market stall, mobile food vans, home based food businesses and fundraisers.

By law, a food business must not start operating without registering, otherwise enforcement action, including prosecution, can apply.

To register or notify

- 1. Contact the Shire for details of the registration process required and any other food safety requirements.
- 2. Complete the Shire notification/registration form and (if required) include design and fit-out specifications of the premises where food is to be handled or any other information required by the Shire.
- 3. Pay the registration fee as required by the Shire.

After the Shire considers the application for registration they will either:

- grant the application, with or without conditions, and issue a certificate of registration specifying the premises in respect of which registration is granted
- refuse the application in writing, setting out the reasons for refusal

Training - skills and knowledge of staff

It's important that anyone handling food or surfaces that come into contact with food (known as a food handler) and their supervisors have the skills and knowledge to handle food properly so that it's safe and suitable to eat.

The FoodSafe training can be done online at https://www.ehawa.org.au/events/event/foodsafe-online-2022 to learn more about what you need to do to ensure staff and supervisors have the appropriate skills and knowledge to handle food safely.

Shire fees and charges

- 1. one-off registration or notification fee -\$75
- 2. annual or other fee (to cover annual inspections costs) -\$150

Inspections

The Shire employs authorised officer (also known as Environmental Health Officer) who have the regulatory power to:

- inspect a food business to make sure the business and staff are operating in accordance with food laws
- investigate food safety complaints someone may make about a business
- investigate a foodborne disease outbreak or food safety incident that a business may be linked to
- take samples for analysis, for example food samples or environmental swabs

You don't need to fear these inspections and you are encouraged to build a good relationship with the authorised officer, who wants to make sure food for sale to the community is safe and suitable.

Do you have a health emergency after hours?



On Home Island:

Call the clinic 9162 7609 – you will hear a pre-recorded message bank that will give you the phone number to the on call mobile.

This will be a 10-digit number starting with 08.

You need to dial the full 10 numbers

On West Island:

Call the clinic 9162 6655 – you will hear a pre-recorded message bank that will give you the phone number to the on call mobile.

This will be a 10-digit number starting with 08.

You need to dial the full 10 numbers

If these options do not work (eg: the network is down, you don't have access to a phone) you can contact the on call staff on the radio, on channel 24.

There is a radio outside both clinics if you need to use.

We hope that with this system, you won't need to message nurses to find out who is on call.

The mobile phones are still relatively new.

We are trialing different numbers (and services) to see what works best for the islands. Because of this, we may need to change the pre-recorded message you will hear when you call the clinic. This will ensure you have the correct number at the time that you're calling the afterhours number.

If you have any feedback on how to contact after hours' health staff, please feel free to drop into the clinic and let us know.

These are short articles about legal issues that may interest you. They are not legal advice. You should always get individual legal advice for your situation.

This is the third of five articles about bail. In this article we will look at some of the common conditions that are attached to bail.

What are some conditions that can be attached to your bail?

Bail often has conditions attached to it. You must comply with the conditions. If you do not, you may be committing an offence, or you may have your bail cancelled or changed. We will talk more about this in the fourth article.

There are certain common conditions that are often attached to your bail. The main one is that you must attend court on a certain day at certain time and attend all future court appearances.

There are other very common conditions that can attach to your bail:

- A monetary condition where you agree that if you do not attend court as required you forfeit (have to pay) a certain amount of money to the state (the government).
- That you report to a police station on certain days and times (for example Mondays and Thursdays between the hours of 9 am and 5 pm).
- That you live at a certain address.
- That you comply with a "curfew". This is where you are not allowed out of where you are living between certain hours. An example might be a curfew from 8 pm to 6 am.
- That you hand in any passports and not apply for others whilst on bail.
- That you provide a "surety". A surety is a person who agrees to forfeit (pay) a certain amount of money to the state if you do not attend court when you are required to do so. The surety does not have to hand over money before you are granted bail. It is only if you do not attend court when required that they forfeit (have to pay) the money to the state.
- A surety condition is set as an amount of money. For example: "A surety in the amount of \$10,000." A surety must usually show that they have enough assets to cover the amount set in the surety condition. They can do this by showing proof of ownership of assets whose value is more than the surety money amount. An example might be home ownership documents, or a car registration.

Protective bail conditions

Special conditions called "protective bail conditions" can also be attached to your bail undertaking. Protective bail conditions are to protect someone else's safety, welfare or property from you, or to stop you interfering with witnesses. These conditions will usually prevent you from contacting a person or people, such as the complainant or witnesses or others such as co-accused (people who have been charged with the same offence/s as you), in any way. Protective bail conditions usually stop you going near the protected person or people. They can also stop you going near or into certain places, such as where the complainant or witnesses live or work or go to an educational institution, such as school or university.

Home detention bail

In certain situations, such as where the court is seriously worried that you will breach (break) your bail conditions, you may be put on home detention bail. This type of bail requires you to stay at home at all times. You must have the permission of Corrective Services to leave your home. There are only certain reasons for which you can leave home, such as for a doctor's appointment.

If you are to be considered for this sort of bail, a Community Corrections Officer (CCO) from Corrective Services must visit your home to assess it. They prepare a report for the court, called a Home Bail Assessment Report, about your suitability for home detention bail. You stay in custody whilst the visit and report are done.

The report considers many factors, including whether you have complied with any bail or court orders you have been given in the past, who else is living in the house and whether there is any criminal activity in the house.

If you are granted home detention bail, there will usually be other conditions attached to it. These may include that you must come to the front door when visited by police or your CCO, obey all lawful directions of your CCO, not consume alcohol or illegal drugs, have a surety and submit to random drug testing. Your home detention bail will be supervised by your CCO.

You will also usually be electronically monitored by an ankle bracelet to make sure you do not leave the place where you live.

In the fourth article we will look at what happens if you breach (break) your bail conditions, if you can apply for bail again if you have been refused bail and whether you can change your bail conditions.

Apakah itu jaminan? III

Ini adalah artikel pendek mengenai perkara undang-undang yang mungkin menarik untuk anda. Ini bukan nasihat undang-undang. Anda mesti selalu mendapatkan nasihat undang-undang sendiri untuk keadaan anda.

Ini adalah artikel ketiga dari lima artikel tentang jaminan. Dalam artikel ini kami akan melihat beberapa syarat biasa yang ada pada jaminan.

Apakah syarat yang boleh diletak pada jaminan anda?

Jaminan selalunya mempunyai syarat yang diletakan padanya. Anda harus mengikut syarat-syaratnya. Jika anda tidak ikut, anda mungkin melakukan kesalahan, atau jaminan anda boleh dibatalkan atau ditukar. Kami akan bicarakan tentang perkara ini lebih lanjut dalam artikel keempat.

Terdapat syarat biasa yang tertentu yang sering diletakan pada jaminan. Perkara utama adalah anda harus menghadiri mahkamah pada hari tertentu pada masa tertentu dan menghadiri semua mahkamah di masa yang akan datang.

Terdapat syarat lain yang sangat biasa yang boleh diletakan pada jaminan anda:

- Syarat keuangan dimana anda bersetuju bahawa jika anda tidak menghadiri mahkamah sebagaimana yang disyaratkan anda kehilangan (perlu bayar) sejumlah uang kepada negeri (kerajaan).
- Bahawa anda repot ke stesen polis pada hari dan masa tertentu (misalnya setiap hari Senin dan Khamis antara jam 9 pagi dan 5 petang).
- Bahawa anda tinggal di alamat tertentu.
- Bahawa anda mengikut "curfew". Disini anda tidak dibenarkan keluar dari tempat anda tinggal antara waktu tertentu. Contohnya mungkin dari jam 8 malam hingga jam 6 pagi anda harus ada dirumah.
- Bahawa anda serahkan pasport dan tidak memohon untuk orang lain semasa jaminan.
- Bahawa anda menetapkan "penjamin". Penjamin adalah seorang yang setuju untuk keluar (membayar) sejumlah uang kepada state
 jika anda tidak menghadiri mahkamah apabila anda dimintak untuk melakukannya. Penjamin tidak harus menyerahkan uang sebelum
 anda dikasi jaminan. Hanya jika anda tidak menghadiri mahkamah ketika dimintak mereka kehilangan (harus membayar) uang kepada
 state.
- Syarat penjamin ditetapkan sebagai sejumlah uang. Contohnya: "Penjamin dalam jumlah \$10,000." Penjamin biasanya harus menunjukkan bahawa mereka mempunyai aset yang cukup untuk menanggung jumlah yang ditetapkan dalam syarat penjamin. Mereka boleh melakukan ini dengan menunjukkan bukti pemilikan aset yang nilainya lebih daripada jumlah uang penjamin. Contohnya mungkin surat pemilikan rumah, atau rejistrasen kereta.

Syarat Perlindungan Jaminan

Syarat khas yang dipanggil "syarat perlindungan jaminan" boleh jugak diletakan pada jaminan anda. Syarat perlindungan jaminan adalah untuk melindungi keselamatan, kesejahteraan atau harta orang lain daripada anda, atau untuk menghentikan anda menganggu saksi. Syarat ini biasanya menghalang anda daripada menghubungi seseorang atau orang, seperti pengadu atau saksi atau orang lain yang tertuduh bersama (orang yang telah dituduh dengan kesalahan yang sama seperti anda), dengan cara apapun. Syarat perlindungan jaminan biasanya menghentikan anda merapat dengan orang yang dilindungi. Ia juga boleh menghalang anda merapat atau pergi ke tempat tertentu, seperti tempat orang yang mengadu atau saksi tinggal atau bekerja atau pergi ke tempat belajar, seperti sekolaan atau university.

Jaminan tahanan rumah

Dalam keadaan tertentu, seperti dimana mahkamah sangat kuatir yang anda akan melanggar (melanggar) syarat jaminan anda, anda mungkin dikasi jaminan dimana anda di taan dirumah. Jaminan seperti ini mengharuskan anda untuk tinggal dirumah setiap masa. Anda harus mendapatkan kebenaran dari Corrective Services untuk keluar rumah. Hanya ada alasan tertentu yang anda boleh kuar rumah, seperti untuk appointment doktor.

Jika anda dipertimbangkan jaminan seperti ini, Community Corrections Officer (CCO) dari Corrective Services harus peresa rumah anda untuk menilainya. Mereka siapkan repot untuk mahkamah, yang dipanggil Home Bail Assessment Report, tentang kesesuaian anda untuk jaminan tahanan rumah. Anda tetap dalam tahanan sementara lawatan dan repot dibuat.

Repot ini mempertimbangkan banyak faktor, termasuk sama ada anda telah mematuhi jaminan atau perintah mahkamah yang telah diberikan kepada anda, siapa lagi yang tinggal dirumah itu dan sama ada terdapat sebarang aktiviti kriminal di dalam rumah.

Jika anda di kasi jaminan tahanan rumah, biasanya terdapat syarat lain yang diletakan bersamanya. Ini mungkin termasuk bahawa anda harus datang ke pintu depan apabila polis atau CCO anda datang pereksa, ikut semua arahan CCO anda, tidak minum alkohol atau amek obat-obat terlarang, mempunyai penjamin dan menyerahkan diri untuk buat drug test. Jaminan tahanan rumah anda akan diawasi oleh CCO anda.

Anda juga biasanya akan dijaga secara elektronik dengan gelang kakik untuk memastikan yang anda tidak meninggalkan tempat tinggal.

Dalam artikel keempat kami akan melihat apa yang akan berlaku jika anda melanggar (melanggar) syarat jaminan anda, jika anda boleh memohon lagi jika jaminan anda telah ditolak dan apakah anda boleh merubah syarat jaminan anda.

Scientists have researched and estimated that our Earth is around 4.5 billion years old.

Earth formed at around the same time as the rest of our Solar System.

Earth revolves around the Sun once every 365.25 days - this is known as one Earth vear.

In one year, Earth rotates like a spinning ball about 366.25 times - they are known as Earth days.

Earth is the fifth largest planet of the Solar System. It has a diameter of 6.371 km / 3.958 mi. It is the largest terrestrial planet. The other terrestrial planets are Venus, Mars, and Mercury.

The name Earth is at least 1.000 years old. It simply translates to "the ground". The Greek name for Earth was Gaia - Mother Earth.

Only 3% of Earth's water is fresh and 97% of it is salty.

The surface of Earth is covered by water, around 71%, only 29% of Earth's surface is covered by land.

The mixture of gases commonly known as air are nitrogen, oxygen, argon, and carbon dioxide. Without them, we couldn't live. The atmosphere of Earth is divided into 6 layers – the troposphere, stratosphere, mesosphere, thermosphere, exosphere, and ionosphere.

Earth has the greatest density out of all the planets in our Solar System. This means it is very compact.

Earth has only one satellite – the Moon, but it also has a couple of temporal artificial satellites.



DIY

DIY Vertical Plant Hanger

Supplies:

- -- scrap wood
- pots
- plantsrope

- metal ringdrill and 3/8" bit
- jigsaw
- sandpaper
- paint and/or stain

Start by placing a pot upside down on the wood. Measure and mark a square around the pot. Squares should be depending on the size of your pot and slightly bigger. Cut squares with saw.

To create a hole for the pots to sit in, first trace the top of the pot in the center of the wood. Then draw another circle that is 5-6mm SMALLER inside the first circle.

Now you'll need to cut the smaller circle out. Use a 3/8" drill bit to create holes in the circle so you could fit a jigsaw blade inside. Then use the jigsaw to cut around the circle until the piece popped out.

And now your pots should fit inside the wood squares!

Next, drill a hole in each corner of the wood, drill bit depending rope used. This will be where the rope threads through.

Sand the wood squares down to remove any splinters and paint or stain them however you

You can leave your pots plain or paint them if you like.

Now it's time to assemble! The size of your hanger will depend on how big and how many pots you're using, so adjust the dimensions as needed.


