Apple Phones

- Open the Camera app from the Home Screen, Control Centre or Lock Screen.
- Select the rear-facing camera. Hold your device so that the QR code appears in the viewfinder in the Camera app. Your device will recognise the QR code and display a notification.
- Tap the notification to open the link associated with the QR code.

Android Phones

- On your compatible Android phone or tablet, open the built-in camera app.
- Point the camera at the QR code.
- Tap the banner that appears on your Android phone or tablet.
- Follow the instructions on the screen to finish signing in.

If you can't scan the QR code, you can try to sign in another way using Google Assistant or Google Lens.

Volunteering

Volunteer numbers are declining in Western Australia.

On Cocos the Shire is tapping into our youth networks to boost numbers in the instance. Tapping into social media giants to rebrand volunteering on TikTok, Instagram and Facebook.

On Cocos, of the total population 15% volunteer through an organisation or group in 2021 compared to 22% in 2016. The lost due to fatigue, burnout, COVID concerns or the temporary population, whatever the case may be there is always the constant relative spike and troughs in this small community.

Supporting food sustainability in the IOT

The Australian Government is prioritising the future sustainability of the Indian Ocean Territories (IOT) with almost \$450,000 in funding for three exciting projects across Christmas Island (CI) and the Cocos (Keeling) Islands (CKI) under the Innovative Agricultural Trials grants program.

The projects funded under this program explore ways to support locally grown fresh and affordable produce, while building important skills and knowledge in sustainable agricultural, aquaculture and farming techniques.

Following the recent application period, Minister for Regional Development, Local Government and Territories Kirsty McBain is pleased to announce the following grants:

- \$150,000 to the Cocos Islands Co-operative Society Ltd to develop a hydroponics facility on CKI, with the aim of supplying 100% of CKI's requirement for targeted leafy green crops.
- \$150,000 to Phosphate Resources Ltd to establish a Climate Controlled Container system on Cl to trial solutions for remote locations with depleted soils and harsh climatic conditions.
- \$144,000 to The Trustee For Lacy Flores Family Trust to establish a high-density vertical hydroponics facility on CKI able to produce a minimum of 200kg of fresh produce every week.

The projects will reduce the communities' reliance on importing fresh produce at high prices, support greater self-sufficiency and will build key skills for future employment and business opportunities.

"Funding these projects will support the IOT communities to explore new ways to grow fresh local produce, reducing the need to import fresh produce at much higher prices," Minister McBain said.

"Building skills and creating future employment and business opportunities for the IOT are among our Government's main priorities for region, as we work together to support food security and self-sufficiency across the islands.

"The responses received to the Innovative Agricultural Trials for the IOT show an exciting road ahead for the region, signaling potential job creation, new industry and development of a sustainable approach to local agriculture and farming for the future."

The Government will continue to keep the community updated as these innovative projects come to life.

Meetings in Canberra

In August 2022, a delegation from the IOT RDO, led by the Committee's Chairperson, Mrs Natasha Griggs, Administrator of Christmas Island and the Cocos (Keeling) Islands, travelled to Canberra to present the new IOT RDO 2030 Strategic Regional Plan, and to highlight the organisation's short-term priorities for the region.

The delegation was very fortunate to have the opportunity to discuss key issues affecting our IOT communities with the Hon Kristy McBain MP, Minister for Regional Development, Local Government and Territories. Topics discussed included IOT freight and flight service issues, environmental and sustainability initiatives, and the progression of digital and telecommunications connectivity in the region.



The delegation also presented the IOT RDO 2030 Strategic Regional Plan to the Department of Infrastructure, Transport, Regional Development, Communication and the Arts (DITRDCA). The attendance of David Mackay, Acting Deputy Secretary, Regional Cities and Territories, was welcomed, as was the presence of representatives from the Regional Intelligence and Local Government, and the Indian Ocean Territories areas of the Department.

IOT RDO 2030 Strategic Regional Plan

The IOT RDO engaged <u>Centred Solutions</u> to develop its new, macro-level *IOT RDO 2030 Strategic Regional Plan*. The development of the plan is a requirement under the <u>RDA Charter</u>. The plan has been developed through research, community and stakeholder engagement, and economic analysis. *The IOT RDO 2030 Strategic Regional Plan* aims to leverage the region's natural assets and community strengths to foster a more diverse economy and a stronger, more resilient and capable region. The plan will drive the work of the IOT RDO, and will also be available for use by the community, community organisations,

private enterprise and government. The *IOT RDO 2030 Strategic Regional Plan* has been accepted by RDA Program Management at DITRDCA, and will be available online later this month.

Annual Business Plan 2022-23

The IOT RDO Committee has developed its *Annual Business Plan 2022-23*. The plan maps the organisation's activities for the coming year, with each activity matched to the priorities and focus areas as outlined in the IOT RDO *2030 Strategic Regional Plan*. The Committee will report on its progress with the implementation of the *Annual Business Plan* via its community newsletters.

Annual General Meeting

The IOT RDO Committee held its annual general meeting (AGM) on 9 September 2022. The Committee is pleased to announce its office holders for the next 12 months, being Farzian Zainal, Deputy Chairperson, Thomas Battcher, Secretary, and Stephanie Lai, Treasurer. As Deputy Chairperson, Farzian will fulfil the duties of Chairperson until such time as the Australian Government appoints a new Administrator for Christmas Island and the Cocos (Keeling) Islands, who will assume the role of Chairperson as per the IOT RDO Constitution.

This was the last meeting for the Committee's Chairperson, Mrs Natasha Griggs. The incoming Deputy Chairperson, Farzian Zainal, thanked Natasha for her ongoing mentorship. Farzian also thanked Natasha on behalf of the Committee, and highlighted the numerous achievements of the IOT RDO which have been made possible under Natasha's leadership. The development of local and regional strategic plans, funding of community infrastructure projects, tourism initiatives including the development of a destination

management and marketing plan for the region and the *Indian Ocean Fest*, development of the <u>IOT Business Directory</u>, and the construction of the pathway and viewing platform on Christmas Island, were all projects which were spearheaded by Natasha. The Committee expressed its heartfelt gratitude to Natasha for her contribution to both the IOT RDO and to our IOT communities.

Construction of the Christmas Island pathway and viewing platform

The two sections of the concrete pathway on Christmas Island, starting at Gaze Road and ending at Rocky Point Crescent, are nearing completion. Similar bollards to those used along William Keeling Crescent on West Island will soon be installed along the path to enhance safety and provide solar-powered illumination. Concrete was recently poured for the columns and precast slab of the new

viewing platform adjoining the walking path. Once the concrete has been cured, the two ends of the path on either side of the viewing platform will be joined. Informative signage for the viewing platform overlooking the Christmas Island Marine Park is being designed in cooperation with Australian Marine Parks. The pathway and viewing platform are expected to be fully completed by November. Both local residents and visitors to the island will benefit from this new community amenity.

Grant funding opportunities

A focus area for the IOT RDO is to support the development of local business capability and capacity, so that local businesses are able to realise their potential, and obtain maximum benefits from emerging opportunities. Part of the IOT RDO's work in this area is to identify and inform our local communities about grant funding opportunities. The latest opportunities, as at 9 September 2022, are available from the Grants section of the IOT RDO website.

The IOTHS includes a 24 hour eight bed hospital and primary care facility on CI and clinics on Home and West Islands in the CKI. The IOTHS is committed to "Working with our communities to keep us healthy for the whole of our lives".

The key responsibilities of the Dental Assistant are to provide a professional dental reception service and clinical assistance to the Dentist, Dental Therapist/Hygienist, Locum Dentists and Dental Specialists at the Christmas Island Health Service and on the Cocos (Keeling) Islands as required.

Administration duties also include all financial transactions and preparing financial reports, annual audits, payroll and reporting to the Committee monthly.

The Manager is also required to plan and facilitate several community events through-out the year. These include but are not limited to New Year's Eve, Melbourne Cup, Membership Drive, Kids Easter and Christmas Party, Altitude Cup (AFL), ANZAC Day and other events to create an income for The Cocos Club.

You may be required to perform other duties as directed from time to time to suit organisational requirements and which are broadly consistent with your role.

Do you want to help guide how Cocos (Keeling) Islands Marine Park is managed?

Parks Australia is seeking up to three community members to be part of an advisory committee to help inform the preparation of the first 10-year management plan for Cocos (Keeling) Islands Marine Park.

The management plan is required under the Environment Protection and Biodiversity Conservation Act and will cover a range of areas, including:

- 1. the vision and objectives for the marine park
- 2. describing the natural, cultural, social, economic and heritage values of the marine park
- 3. the types of management activities that should be prioritised over the next 10 years
- 4. community and stakeholder engagement
- 5. any rules that may be required for particular activities in the marine park

The advisory committee will meet for up to two hours approximately every three months over the next two years, with the first meeting planned for mid-November 2022.

Other members will be drawn from Cocos Marine Care, the tourism industry, and the Pulu Keeling National Park Community Management Committee. At least one marine scientist will also be invited to join the committee.

Up to three additional Cocos (Keeling) Islands community members will be selected through this expression of interest process, which is open to residents aged 18 years or over. These members will be chosen based on:

- 1. ensuring broad and effective representation across the Cocos community
- 2. the particular interests, experience and/or expertise of applicants.

Parks Australia sedang mencari tiga memba masyarakat untuk menjadi bagian dari komiti penasihat untuk membantu menerangkan penyediaan pelan 10 tahun pertama untuk Taman Laut Pulu Cocos.

Pelan pengurusan diperlukan di bawah undang-undang Environment Protection and Biodiversity Conservation dan akan meliputi semua kawasan, termasuk:

SHINING A LIGHT ON SOLAR COMPLAINTS

As one of the world's sunniest landscapes, Western Australia (and the IOT) is home to a booming rooftop solar industry that shows little sign of slowing down as many households look to address rising power bills and reduce pollution.

More than 400,000 WA homes and businesses, or around 36 per cent of customers, are estimated to have rooftop solar connected to WA's main grid, with that figure predicted to swell to 50 per cent by 2030.

Although there's a lot to love about this particular renewable, 189 consumers have complained to Consumer Protection in the past two years about issues such as poor quality parts, companies not responding or providing false and misleading information, and installers failing to use due care and skill.

During a recent radio segment we heard from one consumer whose \$12,500 rooftop solar system had stopped working not long after the installer went out of business. As we make enquiries to see whether the manufacturer can honour the warranty, it's a timely reminder for consumers to thoroughly research who they plan to do business with.

Before agreeing to buy a solar PV system, get several quotes for the total cost, search online for independent reviews and make sure your preferred supplier is accredited by searching the Clean Energy Council (CEC) website.

If a supplier's verbal claims are influencing your decision, make sure to have them included in the written contract and read through all the terms and conditions.

Remember that solar installers are not allowed to use forceful or high pressured sales tactics to get you to buy something, nor can they provide you with false or misleading information. They must also ensure their products and services meet the consumer guarantees.

The system's electrical components must be installed by a licensed electrician working under a licensed electrical contractor. Ask to see these licences and expect to receive an electrical safety certificate for the work. Our colleagues at Building and Energy can assist if you have any electrical compliance concerns.

KOMPLENAN SOLAR

Sebagai salah satu tempat yang paling terang di dunia, Western Australia (dan IOT) adalah rumah kepada industri solar yang berkembang yang menunjukkan sedikit tanda untuk perlahan karena banyak rumah memandangkan nya untuk mengatasi kenaikan bayaran kilap dan mengurangi polusi.

Lebih dari 400,000 rumah dan bisnis-bisnis di WA, atau sekitar 36 persen pelanggan, diperkirakan mempunyai rooftop solar yang disambung ke grid utama WA, dengan nomor yang dijangka itu akan naik sehingga 50 persen pada tahun 2030.

Walaupun ada banyak hal yang disukai tentang energi yang boleh diperbaruhi, 189 pengguna telah mengadu kepada Consumer Protection dalam dua tahun lalu tentang masalah seperti part yang kualiti tidak bagus, kompani yang tidak bertindak balas atau memberikan informasi palsu dan informasi yang mengelirukan, dan tukang pasang yang gagal untuk berhati-hati dan penghetahuan mereka.

Semasa segmen radio baru-baru ini kami mendengar daripada seorang pengguna yang rooftop solar sistem nya nilai \$12,500 telah berhenti bekerja tidak lama selepas yang tukang pasang tidak beroperasi. Semasa kami membuat pertanyaan untuk melihat sama ada yang tukang buat boleh memenuhi waranti, adalah peringatan untuk pengguna menyelidiki dengan teliti dengan siapa mereka bercadang untuk buat bisnis.

Sebelum bersetuju untuk membeli sistem solar PV, dapatkan beberapa quotes untuk harga penuh, carik pertimbangan secara online dan pastikan pilihan supplier anda yang diakreditasi dengan mencarinya di website Clean Energy Council (CEC).

Jika klaim supplier mempengaruhi keputusan anda, pastikan untuk memasukkannya di dalam kontrok tertulis dan membaca semua syarat dan ketentuan.

Ingat bahawa tukang pasang solar tidak dibenarkan menggunakan taktik penjualan yang memaksa untuk membuat anda membeli sesuatu, mereka juga tidak boleh memberikan anda maklumat palsu. Mereka jugak mesti memastikan produk dan serbis mereka memenuhi jaminan pengguna.

Komponen sistem kilap mesti dipasang oleh tukang kilap yang ada lesen yang bekerja di bawah kontraktor tukang kilap yang ada lesen. Mintak untuk melihat lesen ini dan berharap untuk menerima sertifikat electrical safety untuk pekerjaan tersebut. Rakan sekerja kami di Building and Energy boleh membantu jika anda mempunyai sebarang masalah penyesuaian kilap.

What is bail? I

These are short articles about legal issues that may interest you. They are not legal advice. You should always get individual legal advice for your situation.

This is the first article about bail. In this article we will look at what bail is, whether you need to be put on bail when you are charged with a criminal offence or whether bail is not needed at all because the offence is minor.

In the second article we will look at whether you have a right to bail, who considers whether to grant you bail and what they must consider. In the third and fourth articles we will look at some common conditions attached to bail, what happens if you breach (break) your bail and whether you can ask to change your bail. In the last article we will look at some changes to the Bail Act coming into effect on 1 November 2022.

What is bail?

Bail is a process where you are allowed to remain free in the community even though you have been charged with a criminal offence, on the condition that you agree to a bail undertaking (a written promise) to come back to court on all future court dates. There may be other conditions attached to your bail undertaking which you have to obey. You must sign your bail undertaking.

If you are charged with a criminal offence, you are presumed innocent unless you admit your guilt or are proven guilty. It can take time to deal with a criminal offence, especially if you do not admit guilt.

The main purpose of a bail undertaking is to make sure that you will attend court to face your charge and not abscond (run away or hide to escape facing your charge).

There are 3 situations that can occur when you are charged:

- Bail is not needed at all, because the offence is minor. You are released without being put on bail.
- Bail is needed and you are put on bail and sign a bail undertaking before you are released. Your bail continues either until the charge is finalised
 or until bail is revoked (cancelled) by the court. The conditions of your bail can be changed by the court.
- Bail is needed, the question of bail is considered, but you are not given bail and not released. You remain in custody in a remand centre or in prison until your charge is finalised.

Situations where bail is usually not needed

These are situations where bail may not be needed at all:

- 1. You are <u>not arrested</u> but the police give you paperwork that alleges that you have committed an offence. The paperwork will have your first court date on it. Whether you need to be put on bail is considered by the court when you attend court on your first court date.
- 2. You <u>are arrested</u> (taken into custody by the police) and charged with:
- a simple offence (a trivial one that can only be dealt with by the Magistrates Court) or
- an offence which is <u>not</u> a "serious offence" (a serious offence is one that can be dealt with by a higher court and where you can be jailed for 5 years or more).

For a simple offence, the police <u>must</u> make a decision that bail is not needed, unless there is a good reason why bail is needed. For an offence that is not a "serious offence" the police <u>may</u> make a decision that bail is not needed.

If police do not put you on bail, they will give you paperwork alleging you have committed an offence, with your first court date on it, but there will not be any bail conditions.

Some good reasons why the police <u>can</u> decide to put you on bail for these 2 types of offences include that the police think you will commit another offence or commit the same offence again or will hurt someone or damage property. There are other good reasons.

If you are not put on bail by the police, when you go to court on your charge, the court can decide:

- Bail is not needed for your next court appearance (if you are coming back to court again on this charge eg where you seek an adjournment of the charge, or plead not guilty) and release you without any bail conditions if the offence is trivial.
- Bail is needed and put you on bail for the next court appearance.
- Bail is needed but not to give you bail and not release you.

Situations where bail is usually needed

Where you are <u>arrested</u> and charged with a "serious offence" (an offence where you can be jailed for 5 years or more) the police may decide:

- Bail is not needed and release you without conditions
- Bail is needed and put you on bail before releasing you
- Bail is needed but not to give you bail and not release you

If the police decide not to give you bail you must be taken to court as soon as possible. You can then ask the court if it will put you on bail and release you.

In the next article we will look at the factors that are relevant to whether you are granted bail or not.

Apakah itu jaminan? I

Ini adalah artikel pendek mengenai perkara undang-undang yang mungkin menarik untuk anda. Ini bukan nasihat undang-undang. Anda mesti selalu mendapatkan nasihat undang-undang sendiri untuk keadaan anda.

Ini adalah artikel pertama tentang jaminan. Dalam artikel ini kami akan melihat apa itu jaminan, apakah anda perlu diberi jaminan ketika anda dituduh dengan kesalahan kriminal atau jaminan tidak diperlukan sama sekali kerana kesalahannya ringan.

Dalam artikel kedua kami akan melihat apakah anda memiliki hak untuk memberikan jaminan, yang mempertimbangkan sama ada kasi anda jaminan dan perkara yang mesti mereka pertimbangkan. Dalam artikel ketiga dan keempat kami akan melihat beberapa syarat biasa yang di adakan dengan jaminan, apa yang berlaku jika anda melanggar jaminan anda dan sama ada anda boleh minta untuk tukar jaminan anda. Dalam artikel terakhir kami akan melihat beberapa perubahan pada Undang-undang Jaminan yang mulai pada 1 November 2022.

Apa itu jaminan?

Jaminan adalah proses dimana anda dibenarkan bebas di masyarakat walaupun anda dituduh dengan kesalahan kriminal, dengan syarat anda bersetuju menerima jaminan (janji tertulis) untuk kembali ke mahkamah pada semua hari bulan yang akan datang. Mungkin ada persyaratan lain yang ada pada jaminan yang harus anda ikut. Anda harus tanda-tangan perjanjian jaminan anda.

Jika anda dituduh dengan kesalahan kriminal, anda dianggap tidak bersalah kecuali anda mengakui kesalahan anda atau terbukti bersalah. Ia boleh mengambil masa untuk menangani kesalahan kriminal, terutamanya jika anda tidak mengaku bersalah.

Tujuan utama dari janji jaminan adalah untuk memastikan bahawa anda akan hadir ke mahkamah untuk menghadapi pertuduhan anda dan tidak melarikan diri (lari atau bersembunyi untuk melarikan diri daripada menghadapi pertuduhan anda).

Ada 3 keadaan yang boleh berlaku apabila anda di tuduh:

- Jaminan tidak diperlukan sama sekali, karena kesalahan nya ringan. Anda dibebaskan tanpa jaminan.
- Jaminan diperlukan dan anda diberi jaminan dan tanda-tangan perjanjian jaminan sebelum anda dibebaskan. Jaminan anda diteruskan sehingga tuduhan diselesaikan atau sampai jaminan dicabut (dibatalkan) oleh mahkamah. Syarat jaminan anda boleh ditukar oleh mahkamah.
- Jaminan diperlukan, pertanyaan jaminan dipertimbangkan, tetapi anda tidak dikasi jaminan dan tidak dibebaskan. Anda tetap dalam tahanan di pusat penahanan atau kurungan sampai tuduhan anda selesai.

Keadaan dimana jaminan biasanya tidak diperlukan

Ini adalah keadaan dimana jaminan mungkin tidak diperlukan sama sekali:

- 1. Anda <u>tidak ditangkap</u> tetapi polis kasi anda dokumen yang menyatakan anda telah melakukan kesalahan. Dokumen akan ada hari bulan mahkamah pertama anda. Sama ada anda perlu dikasi jaminan akan dipertimbangkan oleh mahkamah saat anda menghadiri mahkamah pada hari bulan mahkamah
- 2. Anda ditangkap (ditahan oleh polis) dan dituduh dengan:
- kesalahan sederhana (kesalahan biasa yang hanya boleh ditangani oleh Mahkamah Majistret) atau
- Kesalahan yang bukan "kesalahan serius" (kesalahan serius adalah kesalahan yang boleh diuruskan oleh mahkamah yang lebih tinggi dan di mana anda boleh di kurung selama 5 tahun atau lebih).

Untuk kesalahan sederhana, polis <u>harus</u> membuat keputusan bahawa jaminan tidak diperlukan, kucuali ada alasan bagus mengapa jaminan diperlukan. Untuk kesalahan yang bukan "kesalahan serius" polis <u>boleh</u> buat keputusan bahawa jaminan tidak diperlukan.

Jika polis tidak kasi jaminan kepada anda, mereka akan kasi anda dokumen menuduh anda telah melakukan kesalahan, dengan hari bulan mahkamah pertama anda, tetapi tidak akan ada sebarang syarat jaminan.

Beberapa alasan bagus mengapa polis <u>boleh</u> memutuskan untuk memberi anda jaminan atas 2 kesalahan termasok polis pikir anda akan melakukan kesalahan lain atau melakukan kesalahan yang sama sekali lagi atau akan mencederakan seseorang atau merosakkan harta benda. Terdapat alasan lain yang bagus.

Jika anda tidak dibebaskan dengan jaminan oleh polis, apabila anda pergi ke mahkamah atas tuduhan anda, mahkamah boleh memutuskan:

- Jaminan tidak diperlukan untuk kehadiran mahkamah anda yang seterusnya (jika anda kembali ke mahkamah lagi untuk tuduhan ini contohnya dimana anda meminta penundaan pertuduhan, atau mengaku tidak bersalah) dan membebaskan anda tanpa sebarang syarat jaminan jika pelanggarannya biasa.
- Jaminan diperlukan dan memberi anda jamiman untuk kehadiran mahkamah seterusnya.
- Jaminan diperlukan tetapi bukan untuk memberi anda jaminan dan tidak membebaskan anda.

Keadaan dimana jaminan biasanya diperlukan

Dimana anda ditangkap dan di tuduh dengan "kesalahan yang serius" (kesalahan di mana anda boleh dikurung selama 5 tahun atau lebih) polis boleh memutuskan:


- Jaminan tidak diperlukan dan lepaskan anda tanpa syarat
- Jaminan diperlukan dan memberi anda jaminan sebelum melepaskan anda
- Jaminan diperlukan tetapi bukan untuk memberi anda jaminan dan tidak membebaskan anda

Jika polis memutuskan untuk tidak kasi anda jaminan anda harus dibawak ke mahkamah secepat mungkin. Anda kemudian boleh bertanya kepada mahkamah apakah itu akan meletakkan anda dengan jaminan dan membebaskan anda.

Dalam artikel selanjutnya kami akan melihat faktor-faktor yang berkaitan dengan apakah anda diberikan jaminan atau tidak.



Because there is always water involved and they have limited ventilation, your kitchen and bathroom can be mould's favourite place to hang out.

Here's how to stop it taking hold.

Firstly, mould growth makes tiles look shabby and old. Secondly, it can be a health hazard.

Here's how you can deal with mould in your home

Proper ventilation

Mould loves the damp, so you should make sure your bathroom and kitchen are well-ventilated.

If you are not showering, keep the shower door open. This ensures proper airflow inside the shower.

Open the kitchen windows after cooking to let the steam out. Even better, turn on the exhaust fan if you have one.

Keep areas dry

An effective way to prevent mould growth is to keep the bathrooms and kitchen dry.

Use a dry cloth to wipe the walls after you shower or cook. Sometimes, even after opening the windows, some moisture might settle on the walls.

When wet towels are left hanging in the bathroom, they add to the moisture content in the room. So, hang them on the line or pop them in the dryer for a few minutes when you've finished with them.

Clean, clean, clean!

In the bathroom, tiles can get covered in soap residue, which over time can provide a porous surface for mould to thrive.

Use a mild tile cleaner or warm water to clean the tiles regularly. Lightly scrub around the grout to ensure that mould does not grow there.

Professional cleaning

And finally, have your tiles and grout cleaned by your local professional to make sure your moisture filled areas stay clean and healthy.


HYDRATE YOUR HEALTH

Being a healthy weight is so important in leading a quality lifestyle. It allows us to enjoy the amazing experiences with our family and friends that living on Cocos offers. Carrying excess weight can put you at an increased risk of developing lifestyle diseases such as Type 2 Diabetes, high blood pressure and heart disease. The fat stored around our mid sections can also increase our risk of breast and bowel cancer.

ARE YOU AT RISK?

Your waist to hip ratio is a measurement you can use to determine whether excess weight may be putting your health at risk.

- Stand up straight and breathe out. Use a tape measure to check the distance around the smallest part of your waist, just above your belly button. This is your waist circumference.
- 2. Then measure the distance around the largest part of your hips the widest part of your buttocks. This is your hip circumference.
- Calculate your WHR by dividing your waist circumference by your hip circumference.



WATER is an essential part in achieving a healthy and balanced diet. Hydration is key for many factors that play a role in weight loss including digestion, nutrient absorption, removal of waste products, temperature regulation and muscle function. Without water we cannot function optimally, and our physical and mental health is compromised.

Some people opt for sugary drinks instead of hydrating with water. Sugary drinks can also affect your weight, increase hunger and overeating and cause tooth decay.

DID YOU KNOW?

- 47% of children consume sugar sweetened drinks every day.
- One can of soft drink a day can lead to
 6.5kg weight gain in a year.
- Drinking 600mL of coke every day for one year is equivalent to 23kg of sugar.
 That's one whole checked baggage allowance!

Would you add 6 TEAS POONS of sugar to your morning coffee? This is how many teaspoons of sugar are in a: 250mL Red bull = 6.8 tsp 375mL Coke = 10 tsp 600mL Powerade = 8.8 tsp 500mL Ice tea = 6.6 tsp

WATER IS BEST SO LET'S REDUCE THE REST

Let's look after health and hydration and our children's and swap sugary drinks for water. Our tap water is safe to drink. Bottled water has no more health benefits than tap water and we all know that plastic bottles have a negative impact on our environment.

HELPFUL HYDRATION HINTS

- Drink water before you feel thirsty especially if you're exercising or it's a hot humid day.
- Drink regularly throughout the day even if you are not thirsty.
- Check your urine colour. If it is pale yellow that's great but if it is dark, then you may be dehydrated (some medications/supplements can change the colour of your urine).
- 1/5 of our water intake comes from food but the rest is from drinking water.

14 DAY CHALLENGE - HOW MUCH SUGAR ARE YOU DRINKING EACH WEEK?

Week 1: Record your daily drink intake and the amount of sugar you are drinking. To work out how many teaspoons of sugar are in your packaged drinks look at the label and divide the total amount of sugar by 4. Four grams of sugar is equal to one teaspoon. To be precise, 4.2 grams equals a teaspoon, but the nutrition facts round this number down to four grams.

Week 2: Decrease the amount of sugar you are drinking by either swapping for water or reducing the number of drinks you consume, or the amount of sugar you add to your hot drinks.

I use a few types of fertiliser;

Best fertilisers for bananas have a very high potash. If using normal NPK mix it is beneficial to add a handful of potassium sulphate and a handful of iron sulphate for each tree when they start to flower.

Urea... good for lawns, sugar cane and greening things up a bit.

Potash for fruiting plants especially bananas and tomato.

Iron sulphate also very good for greening up plants and providing a bit more acid to the soil.

Foliar fertiliser for when I forget to fertilise and have to play catch up...do not use in full sun and take care of mix strength.

Slow release fertiliser of continuous fruiting plants like egg plant and tomato.

Pure sulphur in pastilles I am experimenting with. I am told it will lower the fungal load in the soil which is helpful for bananas when it get a bit too wet. It also helps with creating a less alkaline topsoil in the long term.

Dynamic lifter/chook poo is GOLD. Bit smelly is all.


Any special or targeted soil chemicals/additions should not be "chelated" as this is only suited to acid soils. Our soil is almost pure calcium carbonate, "chelated" means bonded to calcium, so is not very available in our soil environment.




