Waste Management Update

The Department of Water and Environment Regulation (DWER) has directed the Shire to manage access to the transfer stations on both West Island and Home Island. This is not only a requirement of the Shire waste licence conditions but as a result of complaints from the community.

The Shire is in the process of establishing fencing and gates at each of the facilities to control access. It is intended that each site will be open between certain hours each workday for public access.

Waste will continue to be accepted at each site with waste segregation at the gate.

The Shire is investigating short-term measures to reduce this impact including additional kerbside waste collection if necessary.

Water and Wastewater Treatment Projects Cocos (Keeling) Islands West Island

The Department of Infrastructure, Transport, Regional Development and Communications will be undertaking two water and wastewater projects on the Cocos (Keeling) Islands (CKI) West Island.

The projects are:

- construct a new 200 kilolitre per day (kL/day) Seawater Reverse Osmosis (SWRO) Plant for water security
- upgrade the capacity of the existing Wastewater Treatment Plant (WWTP) from 50kL/day to 80kL/day to support future economic development of the island.

The new SWRO will be located on Part Lot 100 Sydney Highway, adjacent to the existing WWTP. To inform the SWRO design, water source drilling and testing activities will be undertaken.

The Department has referred the two projects to the Parliamentary Standing Committee on Public Works (PWC) for Parliamentary approval. The projects can commence following PWC approval.

The PWC Report and Statement of Evidence is available on the Department's website at https://www.infrastructure.gov.au/territories-regions-cities/territories/Cocos Keeling/projects. Community members and organisations will have an opportunity to comment on the projects until 17 March 2022.

It is expected that the projects will commence construction during 2023 and be completed in early 2024.

The projects will be delivered by Water Corporation, who has been providing water and wastewater services to the CKI community since 2001.

The CKI community will be kept informed of these two important projects and the project delivery timeline.

Projek ayer dan rawatan wastewater Cocos (Keeling) Islands Pulu Panjang

Department of Infrastructure, Transport, Regional Development and Communications akan menjalankan dua projek ayer dan wastewater di Cocos (Keeling) Islands (CKI) Pulu Panjang.

Projek-projek tersebut adalah:

- membuat Seawater Reverse Osmosis (SWRO) baru yang menghasilkan 200 kiloliter sehari (kL/sehari) untuk ketahanan ayer
- naikan kapasiti Wastewater Treatment Plant (WWTP) yang ada dari 50kL/sehari ke
 80kL/sehari untuk membantu pembangunan ekomoni masa depan pulu.

SWRO baru akan terletak di Part Lot 100 Sydney Highway, sebelah WWTP yang ada. Untuk menerangkan desain SWRO, penggalian dan pengujian sumber ayer akan dijalankan.

Department telah menyerahkan kedua projek tersebut ke Parliamentary Standing Committee atas Public Works (PWC) untuk persetujuan Parlimen. Projek boleh dimulakan setelah persetujuan PWC.

Repot PWC dan Statement of Evidence boleh didapat di website Department di https://www.infrastructure.gov.au/territories-regions-cities/territories/Cocos Keeling/projects. Masyarakat dan organisasi akan dapat peluang untuk komen projek-projek ini sehingga 17 March 2022.

Projek-projek tersebut diharapkan bermula pada 2023 dan siap pada awal 2024.

Projek-projek tersebut akan dilaksanankan oleh Water Corporation, yang telah menyediakan serbis ayer dan wastewater kepada masyarakat CKI sejak 2001.

Sentencing II - what the court can do before giving you a penalty for your criminal offence

These are short articles about legal issues that may interest you. They are not legal advice. You should always get individual legal advice for your situation.

This is the second of six articles about sentencing (where a court gives you a penalty) when you are convicted (found guilty) of a criminal offence. In this article we will look at the things that the court can do before you are sentenced.

Pre-sentence report (PSR)

Before sentencing you, the court can order a report called a pre-sentence report (PSR) if it thinks that the PSR will help it in deciding what is the best sentence to give you. Sometimes the court must order a PSR. A PSR is prepared by a Community Corrections officer (CCO) from Corrective Services in the WA Department of Justice. The CCO will interview you and may get other information about you.

They will prepare a report that talks about your upbringing, family background, your current family and work situation and your plans for the future - such as whether you want to undertake further education, for example. The report may also say how much responsibility you take for your offending and whether you are remorseful (are sorry) for your offending.

The CCO can comment in the report on what they may feel are appropriate sentencing options for you. An example is where a CCO might say in the report that they think you are suitable to be put on a community-based order.

A PSR can often be given verbally by the CCO if there is a need to sentence you straight away.

Psychiatric or psychological reports, or other reports such as a medical report

The court can also order that one of these reports be prepared if it thinks that you have for example a psychiatric, psychological or other medical problem and the court wants to understand this before giving you a penalty.

These reports are separate to a PSR. The CCO will arrange for the report to be prepared.

"Diversion" programmes, specialist courts or orders before being sentenced

In mainland WA courts, there are a number of programmes you can take part in, or specialist courts that you can be sent to, or orders you can be put on before being sentenced. You are "diverted" to one of these before being sentenced.

The idea behind these "diversion" options is to give you an opportunity to address the underlying reasons for your offending before being sentenced. If you complete the programme or treatment or make a good behaviour change the court can take this into account when giving you your penalty and your penalty may be reduced.

Some examples of these diversion options are:

- treatment for an addiction (eg alcohol, drug or gambling)
- a programme for helping you change your violent behaviour
- a mediation for you to make amends (make up for your behaviour) to a victim, or
- a programme to give you support for mental health problems or an intellectual disability before you are sentenced.

Some of these programmes and orders are available in all West Australian mainland courts, and some are only available in some courts, such as courts in the metropolitan area, or only in Perth Magistrates Court.

The philosophy behind these programmes, orders and specialist courts is that they will help stop you offending again and benefit you and the community generally.

The specialist courts include the Drug Court, the Start Court (for the Mental Health Court Diversion and Support Programme), the Intellectual Disability Diversion Court and referral into a Family Violence court list.

Special programmes include the Alcohol and Other Drug Diversion Programme and the Intellectual Disability Diversion Programme. There are others.

You might also be given an order to adjourn (delay) your matter for sentencing so that you can try victim/offender mediation.

Another order you can be put on is a "pre-sentence order" in situations where otherwise the court would be likely to sentence you to immediate imprisonment. This order allows Community Corrections to work with you for a period before you are sentenced. It may result in you not being sentenced to imprisonment if you successfully work with Community Corrections.

A pre-sentence order must have a supervision requirement (so you are supervised by Community Corrections) and may have a programme requirement and may require you to do unpaid community work.

Most of these options are not available in the Indian Ocean Territories (IOT). In the IOT you could be put on a pre-sentence order if you are in danger of being sentenced to immediate imprisonment.

You are able to transfer your criminal matter to WA mainland courts if you want to ask the court to put you on any of the programmes but you would probably have to live in WA during the time you are in the programme. For example, in the IOT you could seek a referral to the Drug Court but you may have to live in WA whilst you are attending the Drug Court.

Hukuman II – perkara yang boleh dilakukan oleh mahkamah sebelum memberi hukuman atas kesalahan anda

Ini adalah artikel pendek mengenai perkara undang-undang yang mungkin menarik untuk anda. Ini bukan nasihat undang-undang. Anda mesti selalu mendapatkan nasihat undang-undang sendiri untuk keadaan anda.

Ini adalah yang kedua dari enam artikel tentang hukuman (dimana mahkamah memberi hukuman) apabila anda dihukum (didapati bersalah) atas kesalahan anda. Dalam artikel ini kami akan melihat perkara yang boleh dilakukan oleh mahkamah sebelum anda dijatuhkan hukuman.

Pre-sentence Repot (PSR)

Sebelum menjatuhkan hukuman kepada anda, mahkamah boleh memerintahkan repot yang dipanggil pre-sentence repot (PSR) jika dianggap bahwa PSR akan menbantunya dalam memutuskan apakah hukuman yang terbaik untuk diberikan anda. Kadang-kadang mahkamah mesti merintahkan PSR. PSR disiapkan oleh Community Corrections officer (CCO) dari Corrective Services di WA Department of Justice. CCO akan intebiu anda dan mungkin mendapatkan maklumat lain tentang anda.

Mereka akan menyediakan repot yang berbicarakan tentang pendidikan anda, latar belakang pendidikan anda, keluarga anda saat ini dan keadaan kerja dan rencana anda untuk masa depan - seperti sama ada anda ingin melanjutkan pelajaran, contohnya. Repot tersebut jugak mungkin menyatahkan sejauh mana tanggungjawab anda untuk kesalahan anda dan sama ada anda menyesal (mintak maaf) atas kesalahan anda.

CCO boleh memberikan komen dalam repot tentang apa yang mereka rasa pilihan yang sesuai untuk anda. Contohnya iyalah di mana CCO mungkin mengatakan dalam repot bahwa mereka pikir anda sesuai untuk diletakan pada community-based order.

PSR selalunya boleh diberikan secara bersuara oleh CCO jika terdapat keperluan untuk langsung menghukum anda.

Repot Psykiatrik atau psykologikal, atau repot lain seperti repot kesehatan

Mahkamah jugak boleh memerintahkan supaya satu daripada repot ini disiapkan jika ia berpendapat yang anda mempunyai contohnya psykiatrik, psykologikal atau masalah kesehatan yang lain dan mahkamah ingin memahami perkara ini sebelum memberi anda hukuman.

Repot-repot ini lain dari PSR. CCO akan mengurus untuk repot disiapkan.

Program "Diversion", mahkamah specialist atau perintah sebelom dijatuhkan hukuman

Di mahkamah tanah besar WA, terdapat beberapa program yang anda boleh ikut, atau mahkamah specialist yang anda boleh dihantar, atau perintah anda boleh dikenakan sebelum dijatuhkan hukuman. Anda di "mengalehkan" ke salah satu dari ini sebelum dijatuhkan hukuman. Idea di sebalik "diversion" ini adalah untuk memberi anda peluang untuk menangani alasan untuk kesalahan anda sebelum dijatuhkan hukuman. Jika anda menyelesaikan program atau perawatan atau membuat perubahan tingkah laku yang baik mahkamah boleh mempertimbangkan hal ini apabila memberi anda hukuman dan hukuman anda mungkin dikurangkan.

Hukuman II – perkara yang boleh dilakukan oleh mahkamah sebelum memberi hukuman atas kesalahan anda (seterusnya)

Beberapa contoh pilihan diversion ini adalah:

- rawatan untuk ketagihan (eg alkohol, drug atau perjudian)
- program untuk membantu anda merubah tingkah laku anda yang kasar
- mediasi untuk anda menebus kesalahan (memperbaiki tingkah laku anda) kepada mangsa, atau
- sebuah program untuk memberi anda sokongan untuk masalah kesehatan mental atau kecacatan intelektual sebelum anda di jatuhkan hukuman.

Beberapa program ini dan perintah ini tersedia di mahkamah tanah besar, dan beberapa hanya tersedia di beberapa mahkamah, seperti mahkamah di kawasan metropolitan, atau hanya di Perth Magistrates Court.

Filosofi di sebalek program ini, perintah dan and mahkamah specialist ini adalah bahwa mereka akan membantu menghentikan anda melakukan kesalahan lagi dan memberi manfaat bagi anda dan masyarakat.

Mahkamah specialist termasok Drug Court, Start Court (untuk Mental Health Court Diversion dan Support Programme), Intellectual Disability Diversion Court dan referral ke dalam daftar Family Violence court.

Program khas termasuk Alcohol and Other Drug Diversion Programme dan Intellectual Disability Diversion Programme. Ada yang lain.

Anda jugak mungkin diberi perintah untuk menunda (tunda) perkara anda untuk menjatuhkan hukuman supaya anda boleh mencuba mediasi mangsa/pesalah.

Perintah lain yang dapat anda lakukan adalah "pre-sentence order" dalam situasi di mana mahkamah berkemungkinan akan menjatuhkan hukuman penjara segera. Perintah ini memungkinkan Community Corrections untuk bekerja dengan anda selama beberapa waktu sebelum anda dihukum. Ini dapat mengakibatkan anda tidak dijatuhkan hukuman penjara jika anda berhasil bekerja dengan Community Corrections.

Perintah sebelum hukuman harus mempunyai persyaratan pengawasan (jadi anda di jaga oleh Community Corrections) dan mungkin mempunyai keperluan program dan mungkin memerlukan anda melakukan kerja masyarakat tanpa gaji.

Kebanyakan pilihan ini tidak tersedia di Indian Ocean Territories (IOT). Di IOT anda boleh diberikan pre-sentence order jika anda dalam bahaya untuk dijatuhkan hukuman segera.

Anda boleh memindahkan perkara kriminal anda ke mahkamah tanah besar WA jika anda ingin meminta mahkamah memasukkan anda ke mana-mana program tetapi anda mungkin perlu tinggal di WA semasa anda berada dalam program tersebut. Sebagai contoh, di IOT anda boleh mencari referral kepada Drug Court tetapi anda mungkin perlu tinggal di WA semasa anda menghadiri Drug Court.

Love hurts: romance scams on the rise

While there are many success stories of people who've met through apps, websites and social media, there are also numerous tales of scam victims left heartbroken and with a financial loss.

Sadly, dating and romance scams are on the rise in Australia. In WA last year, 85 victims reported losing \$3 million to this type of scam, up from 72 victims losing \$2.2 million dollars in 2020.

Nationally, Australians reported losing more than \$56 million to romance scammers in 2021, up 44 per cent from the previous year, with the majority of losses occurring through social media platforms and mobile apps. Unfortunately we know these figures are just the tip of the iceberg, because many romance scams go unreported to authorities.

Consumer protection agencies are reminding people of the warning signs and that victims aren't just those who are actively seeking a partner – it could be you, your friend or family member.

Scammers will express strong feelings for their victims in a relatively short period of time, and can spend many months building up trust before they ask for money. Scam victims sometimes send money because they feel the need for money is genuine, or they might send money towards an airfare believing that their love interest will visit them.

So before making contact with a potential love-interest, it's important to check their online profile is legitimate by doing a reverse Google Image search or TinEye reverse image search. Another important tip is to arrange to meet safely in-person or ask to speak via video.

Avoid any arrangement with a stranger that asks for upfront payment through money order, wire transfer, international funds transfer, pre-loaded card or gift card, or electronic currency, like Bitcoin, as it is rare to recover money sent this way.

If your bank account details have been given to a scammer, contact your bank or financial institution to stop any further losses. People who have fallen victim to identity theft should contact IDCARE at www.idcare.org or call 1800 595 160, while people targeted by scams can lodge an online report via the WA ScamNet website at www.scamnet.wa.gov.au.

Cinta menyakitkan: penipuan percintaan semakin meningkat

Walaupun terdapat banyak kisah kejayaan orang yang pernah bertemu melalui app, halaman web dan media sosial, terdapat juga banyak kisah mangsa penipuan yang kecewa dan mengalami kerugian duit.

Malangnya, penipuan temu janji dan percintaan semakin meningkat di Australia. Di WA tahon lepas, 85 mangsa melaporkan kehilangan \$3 juta untok jenis penipuan ini, meningkat daripada 72 mangsa kerugian \$2.2 juta dolar pada 2020.

Di peringkat nasional, rakyat Australia melaporkan kerugian lebih \$56 juta kepada penipu percintaan pada 2021, meningkat 44 peratus daripada tahon sebelomnya, dengan majoriti kerugian berlaku melalui platform media sosial dan aplikasi talipun mobile. Malangnya kita tahu angka-angka ini hanyalah puncak gunung ais, kerana banyak penipuan percintaan tidak dilaporkan kepada pihak berkuasa.

Agensi perlindungan pengguna mengingatkan orang ramai tentang tanda amaran dan mangsa bukan sahaja mereka yang aktif mencari pasangan – mungkin anda, rakan atau ahli keluarga anda.

Penipu akan meluahkan perasaan yang kuat terhadap mangsa mereka dalam tempoh yang agak singkat, dan boleh menghabiskan masa berbulan-bulan membina kepercayaan sebelom mereka meminta duit. Mangsa penipuan kadangkala menghantar duit kerana mereka merasakan keperluan duit adalah tulen, atau mereka mungkin menghantar duit ke arah tambang kapal terbang kerana percaya minat cinta mereka akan melawat mereka.

Jadi sebelom membuat hubungan dengan minat cinta yang berpotensi, adalah penting untok selidik profil dalam talian online mereka adalah sah dengan melakukan carian Imej Google terbalik atau carian imej terbalik TinEye. Satu lagi petua penting ialah mengator pertemuan dengan selamat secara peribadi atau meminta bercakap melalui video.



Quarantine Station

The quarantine station was opened in November, 1981. Goats, sheep and cattle bred was the first animals quarantined in the facility. 2 local Cocos Malay men were employed and taught many skills. Animals from other countries were tested, treated and cared before it could make it to the mainland Australia. A set of stamps was even issued, in 1996, to commemorate the quarantine station.

In 2006, 8 elephants was housed in the quarantine station before it was cleared for transportation to Zoos in Sydney and Melbourne.

D.I.Y Face Mask

You will need:

- Cotton fabric (10 x 6-inches or roughly 25 x 15 cm)
- 2 x 6-inch (15cm) pieces of elastic or rubber bands, hair ties or strips of cloth
- Sewing machine (ideally)
- Needle and thread
- Scissors
- Pins
- Jewellery wire, or thin wire (optional)

To make a face mask with a sewing machine, first, cut your material to around 10 x 6-inches or roughly 25 x 15 cm.


If you want to make it really clear which part of your mask is the front and which is the back, use two different materials, this will help you avoid putting on the mask back to front (which is not recommended for hygiene purposes). Next, place your two pieces of fabric on top of each other. You want the pattern that you'd like to be on the 'front' of your mask face down. The piece of material facing up towards you will be the inside of your mask.

Next, fold over the long sides of the material around 1/4-inch or 0.5 -1cm. Pin in place and hem. Hem just means folding the edges of your material over and stitching them so that your fabric will not fray and will stay together. You could also add some thin wire into the top hem of your face mask to help you shape it around your nose, and to stop your glasses fogging up, jewellery wire works well for this. To add wire, place it along the top length of the material, and then fold over and sew it down.

Once you have hemmed the length of your face mask, fold over the sides of your face mask around 1/2 an inch (1.5cm), pin and hem the sides too.

Once you have created your side hem, you can thread your elastic or hair ties through it. You'll need a needle to do this, or a pin, or safety pin or basically anything that you can use to poke the elastic through your hem.

With your ties threaded through the sides of your mask, tie your elastic or hair ties in secure knots, and move the knots until they can be tucked inside the hem. You can then adjust your face mask to fit your face, and add some stitches on either end of your face mask to keep your elastic in place.






