#### Working with Children Checks II

These are short articles about legal issues that may interest you. They are not legal advice. You should always get individual legal advice for your situation.

This is the second article about Working With Children Checks (WWCC) under the Working with Children (Criminal Record Checking) Act 2004 (WA)(CI) and the Working with Children (Criminal Record Checking) Act 2004 (WA)(CKI). WWCCs are checks performed on people who work with children, and are designed to protect children. You should read the first article before reading this article.

The law classes offences into a hierarchy of Class 1, Class 2 and Class 3 offences. This article looks at the hierarchy of classes of offences under the law. It then looks at how the class of offence determines how the CEO of the Department of Communities must deal with your application for a WWCC card if you have been charged with or convicted of an offence.

#### What are Class 1 offences?

Class 1 offences are seen as the most serious offences for working with children law. Class 1 offences are offences of a sexual nature committed against or while a child is under 13 years. Examples include sexual penetration of a child under 13, sexual coercion of a child under 13, procuring, inciting or encouraging a child under 13 to engage in sexual behaviour and sexually penetrating a child under 13 known to be a lineal relative or a de facto child, among many others.

#### What are Class 2 offences?

Class 2 offences include many offences, both of a sexual nature and otherwise. For example, it includes offences such as murder and offences of significant harm to others, such as grievous bodily harm, many sexual offences of different kinds, child exploitation offences, offences of other types of harm to children and many others.

It includes offences under state-based Acts other than the *Criminal Code* and Commonwealth offences. For example, it includes drug offences involving children under the *Misuse of Drugs Act 1981* (WA)(CI) or *Misuse of Drugs Act 1981* (WA)(CKI), such as supplying drug paraphernalia to a child. It includes offences of leaving a child unsupervised in a vehicle and failing to protect a child from significant harm under the *Children and Community* Services Act 2004 (WA)(CI) or *Children and Community Services Act 2004* (WA)(CKI) and offences under other state-based Acts.

It includes sexual offences against or involving children under the Commonwealth *Crimes Act 1914*. It includes child exploitation offences under the Commonwealth *Criminal Code 1995*, such as child pornography or child abuse offences.

This class is the second most serious class of offences under the working with children law.

#### What are Class 3 offences?

Class 3 offences are all other offences not in Class 1 or Class 2.

# How do charges/convictions for Class 1, 2 or 3 offences impact on the CEO's decision about giving you a WWCC card? Where you must be given a WWCC card

The CEO must give you with a WWCC card (called an "assessment notice") if you:

- do not have any convictions nor pending charges against you
- were charged with a Class 3 offence but were not convicted of it
- in certain circumstances where you have a pending Class 3 charge.

#### Where you must be given a negative notice - no WWCC card

In one situation, the CEO <u>must</u> give you a negative notice. This is where you were convicted of a Class 1 offence when you were an adult. You will have a life-long prohibition on working with children. An example might be if you were convicted of sexual penetration of a child under 13 years, and you were over 18 years when you committed the offence.

# Where you <u>must</u> be given a WWCC card unless there are particular circumstances that indicate you should be given a negative notice

In some situations, the CEO <u>must</u> give you a WWCC card <u>unless</u> because of the particular circumstances of the case, you should be given a negative notice.

#### Working with Children Checks II continued...

Examples of this include where:

- you were charged with, but not convicted of, a Class 1 or Class 2 offence
- you were convicted of a Class 3 offence or
- where you have a pending Class 3 charge and your employer or the Commissioner for the charge makes it inappropriate for you to continue to carry out child-related work.

There are a number of factors that the CEO has to think about in making the decision.

#### Where you must be given a negative notice unless there are exceptional circumstances

In some situations, the CEO must give you a negative notice, unless because of the exceptional circumstances of the case they decide you should be given an assessment notice. These situations include where:

- you committed a Class 1 offence when you were a child
- you have committed a Class 2 offence as an adult
- you have a pending Class 1 or Class 2 offence
- you have committed a Class 3 offence and the CEO reasonably believes you committed an indecent act while committing that offence.

There are a number of factors that the CEO has to think about in making the decision.

In the next article we will look at how long WWCC cards are current, interim negative notices, getting negative notices reviewed and applying to cancel negative notices.

#### Working with Children Checks II

Ini adalah artikel pendek mengenai perkara undang-undang yang mungkin menarik untuk anda. Ini bukan nasihat undang-undang. Anda mesti selalu mendapatkan nasihat undang-undang sendiri untuk keadaan anda.

Ini adalah artikel kedua tentang Working With Children Checks (WWCC) di bawah undang-undang Working with Children (Pemeriksaan Rekod Kriminal) 2004 (WA)(CI) dan Working with Children (Pemeriksaan Rekod Kriminal) 2004 (WA)(CKI). WWCCs adalah cek yang dilakukan pada orang-orang yang bekerja dengan anak-anak dan tujuan nya adalah untuk melindungi anak-anak. Anda harus membaca artikel pertama sebelom membaca artikel ini.

Undang-undang kesalahan bertingkat dalam Kelas 1, Kelas 2 dan Kelas 3. Artikel ini melihat tingkat kelas kesalahan di bawah undang-undang. Ia kemudian melihat bagaimana kelas kesalahan menentukan cara CEO dari Department of Communities mesti berurusan dengan permohonan anda untuk kad WWCC jika anda telah didakwa atau dihukum kerna kesalahan.

#### Apakah kesalahan Kelas 1?

Kesalahan Kelas 1 dipandang sebagai kesalahan paling serius untuk undang-undang bekerja dengan anak-anak. Kesalahan Kelas 1 adalah kesalahan bersifat seksual yang dilakukan terhadap atau semasa anak-anak berumur 13 tahun. Contohnya termasuk hubungan seksual dengan anak-anak di bawah 13 tahun, paksaan seksual dengan anak-anak di bawah umur 13 tahun, mendapatkan, mengoda atau mendorong anak-anak di bawah umur 13 tahun melibatkan diri dalam tingkah laku seksual dan hubungan seksual dengan anak-anak di bawah umur 13 tahun dikenal sebagai keluarga rapat atau anak tiri, antara ramai lagi.

#### Apakah kesalahan Kelas 2?

Kesalahan kelas 2 termasok banyak kesalahan, baik yang bersifat seksual maupun sebaliknya. Misalnya, ini termasok kesalahan seperti membunuh dan kesalahan yang merugikan orang lain, seperti kecederaan pada badan yang terok, berbagai jenis kesalahan seksual, kesalahan mengambil kesempatan buruk terhadap anak-anak, kesalahan jenis lain yang menyakiti anak-anak dan lain-lain lagi.

Ini termasuk kesalahan di bawa undang-undang negeri selain dari Criminal Code dan kesalahan Komanwel. Misalnya, ini termasuk kesalahan drug yang melibatkan anak-anak di bawah undang-undang Misuse of Drugs Act 1981 (WA)(CI) atau Misuse of Drugs Act 1981 (WA)(CKI), seperti menyediakan bekakas drug kepada anak-anak. Ini termasuk meninggalkan anak-anak tanpa pengawasan dalam kereta dan gagal melindungi anak-anak dari bahaya di bawah undang-undang Children and Community Services Act 2004 (WA)(CI) atau Children and Community Services Act 2004 (WA)(CKI) dan kesalahan di bawah undang-undang negeri.

Ini termasuk kesalahan seksual terhadap atau melibatkan anak-anak di bawah Commonwealth Crimes Act 1914. Ia termasuk kesalahan mengambil kesempatan buruk terhadap anak-anak di bawah Commonwealth Criminal Code 1995, seperti pornografi anak-anak atau kesalahan penderaan anak-anak.

Kelas ini adalah kelas kesalahan kedua paling serius di bawah undang-undang bekerja dengan anak-anak.

#### Apakah kesalahan Kelas 3?

Kesalahan Kelas 3 adalah semua kesalahan lain yang tidak termasuk di Kelas 1 atau Kelas 2.

Bagaimana tuduhan/hukuman untuk kesalahan Kelas 1, 2 atau 3 memberi kesan kepada keputusan CEO untuk kasi anda kad untuk bekerja dengan anak-anak?

#### Dimana anda mesti di kasi kad untuk bekerja dengan anak-anak

CEO mesti kasi anda kad untuk bekerja dengan anak-anak (dipanggil "notis penilaian") jika anda:

Dalam satu keadaan, CEO nya <u>mesti</u> kasi anda notis negatif. Di sinilah anda di hukum karena kesalahan Kelas 1 saat anda dewasa. Anda akan mempunyai larangan seumur hidup untuk bekerja dengan anak-anak. Contohnya mungkin jika anda dihukum karena hubungan seksual dengan anak-anak di bawah umur 13 tahun, dan umur anda lebih dari 18 tahun ketika anda melakukan kesalahan tersebut.

# Dimana anda <u>mesti</u> di kasi kad untuk bekerja dengan anak-anak kecuali terdapat keadaan tertentu yang menunjukan anda harus di kasi notis negatif

Dalam beberapa keadaan, CEO nya <u>mesti</u> kasi anda kad untuk bekerja dengan anak-anak <u>kecuali</u> karena keadaan tertentu kes itu, anda harus di kasi notis negatif.

#### Contohnya termasuk dimana:

- anda di tuduh dengan, tetapi tidak di hukum dengan, kesalahan Kelas 1 atau Kelas 2
- anda di hukum dengan kesalahan Kelas 3 atau
- dimana anda mempunyai tuduhan Kelas 3 yang belum selesai dan tempat kerja anda atau Commissioner for Police telah memberitahu CEO nya tentang kebimbangan bahawa tuduhan itu membuat anda tidak pantas untuk terus menjalankan pekerjaan yang berhubugan dengan anak-anak.

Ada beberapa faktor yang CEO nya perlu fikirkan dalam membuat keputusan.

#### Dimana anda mesti di kasi notis negatif kecuali terdapat keadaan luar biasa

Dalam beberapa keadaan, CEO nya mesti kasi anda notis negatif, kecuali karena keadaan luar biasa dari kes itu mereka memutuskan anda harus di kasi notis penilaian. Keadaan ini termasuk dimana:

- anda melakukan kesalahan Kelas 1 semasa anda masih anak-anak
- anda telah melakukan kesalahan Kelas 2 sebagai orang dewasa
- anda mempunyai kesalahan Kelas 1 atau Kelas 2 yang belum selesai
- Anda telah melakukan kesalahan Kelas 3 dan CEO nya cukup yakin bahawa anda melakukan perbuatan tidak senonoh semasa melakukan kesalahan itu.

Ada beberapa factor yang CEO nya perlu fikirkan dalam membuat keputusan.

Pada artikel berikutnya kami akan melihat berapa lama masanya kad untuk bekerja dengan anak-anak, notis negatif sementara, mendapatkan pertimbangan notis negatif dan memohon untuk membatalkan notis negatif.






