Starting work at a young age with the police cadets in Victoria, over a 20-year career I progressed to be the officer in charge of police stations in urban and rural areas. During this time, I was awarded the Queen's Gallantry Medal and the National Medal and I quickly learnt many of life's lessons with respect to leadership, integrity and trust. Having a "green change" I developed and ran a market garden for a number of years in Victoria. Bermula kerja di umur yang muda dengan kadet polis di Victoria, selama 20 tahun masa kerja, saya naik menjadi opisa yang menanggong stesen polis di kawasan bandar dan luar bandar. Pada masa ini, saya dianugerahkan Queen's Gallantry Medal dan National Medal dan dengan cepat saya mempelajari banyak pelajaran hidup dengan kepimpinan, kejujuran dan kepercayaan. Memiliki "green change" saya membangun dan menjalankan market garden selama beberapa tahun di Victoria. Community Art Project – Water Tank & Retail Precinct - Home Island

The water tank behind the Home Island gym has been there since I was a kid. I think there was an older water tank which was steel or corrugated in structure above ground before that.

Over the years it has been given a coat of paint here and there but nothing like what is to be revealed to the public, designed by the public, with the help of the public.



Lawry Halden our artist in residence for four weeks has integrated some designs and images which the students of the CKIDHS and community have sketched out. "The images represent us as a community" they all said.

Lawry is also undertaking another art project on the Retail Precinct wall which will totally enhance the entry statement to the island.

Images of nature, historical and sporting life on Cocos will adorn the 360° walls of the tank. It's a

carousel of sights that everyone will thoroughly enjoy and will embrace its significance for the many years to come.

The water tank mural is open to anyone who wants to participate. Lawry will be happy to teach and show you how to paint using a spray paint medium. He has a wealth of knowledge and has been involved in many mural projects across the Perth metro area. Community members are welcome to attend the community sessions Wednesday, Thursday and Friday mornings at 8 in the morning.

The upgrade of the Retail Precinct is coming along nicely. A blank canvass to create something wonderful and welcoming.



The retail precinct was the former medical clinic which was built in the late 70's and ceased operating when the new clinic was built. The local nurse was also accommodated here where the boutique shop *Tidal Accents* is now. The restaurant was an earlier establishment and allowed for tourists and visitors to attend regular meals on Home Island. A verandah for the restaurant was constructed in the early 2000's to assist with the increased number of patrons.



The designs are a string of cultural, traditional, religious, and natural images all flowing on the four blank canvases.

It will take Lawry a couple of weeks to finalise the mural. The community can see the progress of the project as photos will be uploaded to our Facebook page or by dropping by.

The inspiration of the design is a combination for the love of Cocos and what makes Cocos so unique to the rest of the world – The Spirit of the Race. The visions of nature, the use of the natural environment for our livelihood, our understanding and acceptance of religious beliefs are all integrated in an artform that flows from one scene to the next, seamlessly.

Lawry inspired the Shire to commission him to begin these mural projects. His creations of last year can be seen on a number of the Water Corporation's infrastructure on Home Island making.

When both murals are complete Lawry will have hidden a few secrets in the designs. See if you can make these out and let us know!

The Spirit of the Race

The Spirit of the Race is the idea behind the Retail Precinct mural. Two Jukungs are seen between the waterfalls jostling for position. It is difficult to see whether they are leading the field, but their individual competition is magnified by the archway.

Water can be seen falling from above in the central section of the artwork which suggests the shape of an Ogee arch. This represents divinity providing and looking on as well.





To the left a gigantic kemudi steered by an unseen hand is the backdrop of the piece.

A further jukung can be seen below it, battling the waves on the gruelling course in the olden days, out to Pulu Luar. It turns out that they are the ones leading the way for the others to follow.

White Terns are calmly fishing nearby. The strange, shapely pieces of timber and ropes at either end of the mural are simply there for their nautical appearance and as bookends to the artwork.

Flowers are displayed each side of this centrepiece indicating the celebration of the event adorned by Ipomoea Pes-capia, Frangipani and Kembang Waru. Local flowers.

The angle of the horizon suggests that the viewer is also onboard a jukung. It tilts down to the left and then up to the right where everything is under water.

Maori Wrasse, Manta Ray, Lion fish, miscellaneous small fry and some coral reef, here and there make up the scene.

Projek Art Masyarakat – Tangki Ayer & Kedeh Kecil - Kampong

Tangki ayer di belakang gym di kampong sudah ada sejak saya masih kecil. Saya rasa ada tangki ayer yang lebih lama yang terbuat dari besi atau corrugated yang di bangonkan di atas tanah sebelum nya.

Selama bertahun-tahun telah di sapu cet tapi tidak seperti apa yang akan ditunjukan kepada masyarakat, desain oleh orang ramai, dengan bantuan orang ramai.



Lawry Halden artis kami selama empat minggu telah satukan beberapa desain dan gambar yang telah di lukis oleh anak-anak dan masyarakat. "Gambargambar ini menunjukkan kami sebagai masyarakat" kata mereka.

Lawry juga sedang menjalankan satu lagi projek di dinding Retail Precinct yang akan membaguskan pemandangan bila sampeh di kampong.

Gambar alam, sejarah dan kehidupan olahraga di Cocos akan mencantikan seputar tangki

ayer. Ini adalah pemandangan yang semua orang akan benar-benar suka dan akan menerima kepentingannya untuk beberapa tahun yang akan datang.

Lukisan tangki ayer terbuka untuk siapa saja yang mau ikut. Lawry dengan senang hati untuk mengajar dang menunjukkan cara melukis mengunakan spray paint. Dia memiliki banyak pengetahuan dan telah terlibat dalam banyak projek lukisan di seluruh kawasan Perth. Masyarakat dipersilahkan untuk menghadiri sesi masyarakat pada hari Rabu, Khamis dan Jumaat pagi jam 8 pagi.

Pembagusan Kedeh Kecil sedang berjalan dengan baik. Kanvas kosong untuk menciptakan sesuatu yang indah dan menyambut.



Kedeh kecik adalah bekas klinik yang dibangunkan pada akhir 70-an dan berhenti beroperasi apabila klinik baru dibuat. Nurse tempatan jugak tinggal disini di butik *Tidal Accents* yang sekarang. Restoran jugak adalah tempat yang lebih awal dan mengizinkan turis dan pelawat untuk makan di kampong. Emper untuk restoran dibuat pada awal tahun 2000-an untuk membantu tambah pelanggan.



Desain adalah gambar budaya, tradisional, religi, dan alam, semua mengalir di dindin.

Lawry akan membutuhkan beberapa minggu atau lebih untuk menghabiskan lukisan ini. Masyarakat boleh lihat progres dari gambar projek yang akan di letak di Facebook kami.

Inspirasi desain adalah kombinasi dari kecintaan Cocos dan apa yang membuat Cocos begitu unik kepada seluruh dunia. Penglihatan alam, pengunaan alam semula jadi untuk penghidupan kami, pemahaman dan penerimaan kami terhadap kepercayaan agama semuanya disatukan dalam lukisan yang mengalir.

Lawry telah memberi insprisai kepada Konsel untuk menugaskannya untuk memulakan projek lukisan ini. Lukisanya tahun lepas membuat bangunan Water Corporation lebih menarik perhatian.

Apabila kedua-kedua lukisan kami siap Lawry telah menyembunyikan beberapa rahasia dalam desainnya. Lihat jika anda boleh dapat dan beritahu kami!

Semangat Perlumbaan

Semangat Perlumbaan adalah idea di sebalik lukisan di Kedeh Kecik. Dua jukung boleh dilihat antara gelumbang yang saling merebut tempat. Susah untuk dilihat siapa yang didepan, tetapi persaingan individu diperbesarkan oleh archway.

Ayer boleh dilihat jatuh dari atas di bagian tengah lukisan yang menunjukkan bentuk Ogee arch. Ini menunjukkan keagamaan dan pengawasan jugak.





Di sebelah kiri kemudi yang dikemudikan oleh tangan yang tidak kelihatan adalah latar belakang lukisan itu.

Satu jukung lagi boleh dilihat di bawahnya, melawan ombak di perjalanan yang meletihkan di masa lalu, ke Pulu Luar. Ternyata merekalah yang memimpin jalan untuk diikuti yang lain.

Burung cuwit-cuwit tenang mencari makan. Kepingan kayu dan tali yang pelik dan cantik di ujung lukisan hanya ada situ untuk penampilan yang berkenaan dengan laut dan sebagai penghujung kepada artwork.

Kembang yang di tunjukkan di kiri kanan centrepiece ini menandakan sambutan acara yang dihiasi oleh Ipomoea Pes-capia, Kembang semoja dan Kembang Waru. Kembang tempatan.

Dari segi kakik langit menunjukkan pandangan dari jukung jugak. Ia miring ke bawah di kiri dan ke atas di kanan dimana semuanya ada di bawah ayer.

Ikan iju, Pareh, Ikan pasang, beberapa macam anak ikan dan karang, disini dan disana menghiasi pemandangan.

Chicken and Garden Plots - Home Island

The latest updates

The Shire will be commencing on what is an exciting and challenging project upgrading the Home Island garden plots. Ongoing engagement and working collaboratively with the plot 'owners' to make marked improvements to the site. Overgrown and in need for some intervention, we will be utilising the raw materials from the gardens, creating opportunities for sustainable farming, and using the natural surroundings to create shelter and shade. Collectively we want to move forward and promote good farming practices.

Clearing has started! One unused plot has been cleared to make way for a true community garden.



The plots serve as an ideal location to breed chickens, away from the kampong where previously noise and smell was a problem. The area has good soil contents, perfect for growing a variety of local fruits such as bananas, tapioca, sugar cane, guava, breadfruit trees and others.

The Shire and the community are working together to establish new strategies to effectively manage these plots and the new community garden amongst the privately managed gardens.


One which will be inclusive and accessible to all.

Some of the issues surrounding the plots have been the introduction of stored building materials and equipment which has lent itself as a refuge for feral cats, vermin, wasps and mosquitos. It is presents a hazard for navigating through the plots.

Putting stronger control measures in this area will be a challenge and the need for change will be a main priority. The Shire will be demolishing any unused structures and clearing as many unused plots as possible to make way for community gardens and communal groves of fruit trees. It will create valuable space to plant native trees, drinking coconut trees, and fruit trees.

The long-term goal is to have productive and self-sufficient garden plots where green waste is turned into composting materials. Creating microclimates amongst the vegetation where different plants can coexist and thrive. Maintaining the balance in the soil and building structures that will capture and store valuable rainwater and cycle this effectively into the gardens.





Pictured to the left is an example of a concept design of a community garden designed by community members.

Our plan is to introduce raised garden beds, pathways for easy access and common areas such as gazebos for resting.

We want and encourage residents that have skills in

farming, horticulture, propagation, and the like to share their ideas and expertise with us.

In consultation with the garden plot 'owners' and the community, a concept plan will be drafted and advertised for community feedback.

Farma Ayam dan Kebon - Kampong

Berita terkini

Konsel akan mulakan projek yang menarik dan mencabar untuk membaguskan farma di Kampong. Keterlibatan dan bekerjasama dengan 'pemilik' kebon untuk membuat pembagusan yang nyata. Semak dan perlu dibuat sesuatu, kami akan memanfaatkan bekakas dari kebon, membuat peluang untuk perkebonan yang berkelanjutan, dan menggunakan persetikaran untuk membuat tempat berteduh. Secara kolektif kami ingin maju dan mempromosikan perkebonan yang bagus.

Pembersihan sudah bermula! Satu plot yang tidak digunakan sudah dibersihkan untuk dijadikan kebon masyarakat.



Tempat yang sesuai untuk piara ayam, jauh dari kampong di mana sebelumnya bising dan busuk adalah masalah. Kawansan tersebut mempunyai tanah yang bagus, sesuai untuk menanam berbagai jenis buahbuahan seperti pisang, dandar, tebu, jambu, pigu dan lain-lain.

Konsel dan masyarakat bekerjasama untuk menetapkan strategi baru untuk menguruskan farma ini dengan berkesan dan kebon masyarakat yang baru di antara kebon-kebon yang di jaga secara pribadi.

Yang mana boleh di pakek oleh semua.

Beberapa masalah seputar kebon adalah penyimpanan bekakas yang telah menjadikan tempat untuk kucing, tikus/binatang lain, wasps dan nyamok. Ini menimbulkan bahaya untuk memasuki tempat ini.


Meletakkan kawalan yang kuat di kawasan ini akan menjadi satu cabaran dan keperluan untuk perubahan akan menjadi keutamaan utama. Konsel akan merombak bangunan yang tidak digunakan dan akan melapangkan sebanyak mungkin farma yang tidak digunakan untuk membuat kebon buah-buahan masyarakat. Ini akan membuat tempat untuk menanam pokok asli, pokok kelapa minum, dan pokok buah-buahan.

Tujuan jangka panjang adalah untuk mempunyai kebon yang produktif dan terdiri sendiri dimana sampah pokok boleh dijadikan kompos. Membuat microclimates di antara pokok-pokok dimana pokok yang lain boleh hidup. Menjaga balance tanah dan buat

menangkap

kebon.





Gambar sebelah kiri adalah contoh desain kebon masyarakat yang di membadesain oleh memba masyarakat.

Rencana kami adalah membuat petak untuk pokok yang ditinggikan, tempat jalan untuk senang akses dan tempat untuk gazebo untuk berehat.

Kami dan mau menggalakkan penduduk vang mempunyai

kebolehan dalam mengebon, pengetahuan perkebunan, propagation, dan sebagainya untuk mengongsi idea dan kepakaran dengan kami.

Dalam perundingan dengan 'pemilik' kebon dan masyarakat, plan akan dirancang dan di abetais untuk pendapat masyarakat.



COMMUNITY FUNDING PROGRAM

GRANT GUIDELINES

Scope

To support new and existing local businesses to improve amenity, stimulate business activity and provide direct benefits to the Shire of Cocos (Keeling) Islands Community in a manner that is fair, equitable and transparent.

The Shire of Cocos (Keeling) Islands Strategic Community Plan 2016 – 2026 identifies the need to encourage economic stability for the Islands. The Shires Corporate Business Plan further defines the aspiration to support employment and promote business opportunities. The Business Improvement Grants Program aims to support local businesses in achieving the goals and aspirations as detailed in the Strategic Community Plan.

Grants of up to 50% of the total project cost up to a maximum grant of \$3,000 will be available for eligible applicants for approved project and subject to budget allocations.

Eligibility

In order to be eligible for a grant, a business must meet the following criteria:

- Be a legally constituted entity, an individual or business with an Australian Business Number (ABN);
- Have a demonstrated investment in the Shire; such as a lease of at least three years or ownership of a premises located within the Shire; to be determined at the discretion of the Shire;
- Have all current insurances, permits and licences for business operation. These
 approvals must be obtained prior to any application being approved;
- Have all current insurances, permits and licences for the works/services/project proposed. These approvals must be obtained prior to any funds being dispersed;
- Have received approval of the grant being successful prior to the commencement of the project (grants will not be given for works already undertaken).
- Have not been approved for funding under this program previously in the current financial year (maximum one grant per applicant per financial year).
- Businesses which are solely home based will be ineligible.
- The business must not have any outstanding debts with the Shire.

Types of Projects Supported

- Projects that improve amenity, stimulate business activity, and provide direct benefits to the Shire of Cocos (Keeling) Islands Community such as (but not limited to):
 - o Signage (Council approved)
 - Specialised equipment that increases services not currently available
 - Formal training

Grants will NOT be considered if:

- An outline of the original aims/objectives of the project and an explanation of how the funding assisted in meeting these objectives;
- Photos/evidence of completed project.
- Failure to satisfactorily complete the acquittal requirements may disqualify recipients from receiving their funding and further grants or financial assistance.

Small Jukung Restoration Project

The small jukung which belonged to the Nek Dari family and has proudly been displayed in the Shire foyer will be getting a facelift with help from the Cocos Islands Youth Council.

The jukung named "Buah Hati" translated roughly as "Prized" or "Precious" was built in 1935. It served the Dari family as a fishing boat which the children took on most days of the week fishing and gathering for the family.



Sails were hard to come by

during the 40's and early 50's because of the cost and availability of the material. The boat was either oared and poled like a traditional *Gondola* to and from the fishing grounds.

The project will include sanding, filling gaps and painting the hull. Enhancing the timber frames inside and sealing the ironwood with varnish. Most of the earlier jukungs were entirely made from ironwood. It is a very rare sight to see this in a newer jukung.

The rigging and its hardware will be replaced however there are some hardware fixtures like the brass blocks and thimbles which were built by hand from the late Nek Ituk. He also fabricated much of the hardware for jukungs over his lifetime in the community. His profound skill in making cleats, swivels, mast yokes and many more intricate but functional workpieces will last forever.

Once fully restored we have engaged an elder to demonstrate to the CIYC members on how to rig this boat and how to best sail it. Some of the CIYC members are already strong sailors and have been joining the next generation jukung teams. It would be a great opportunity to teach the basics of sailing the jukung, learn the Cocos Malay terminology of the components to acquire a better understanding and connection with boat and tradition.

Depending on the availability of materials and the volunteered time we expect that the project will take a couple of months to complete.
